Purpose of Activity/Assignment:

The nutrition situation in Lao PDR remains concerning, with key indicators showing minimal improvement. Stunting rates among children remained stagnant, from 33% in 2017 to 32.8% in 2023, indicating ongoing issues with chronic undernutrition. Wasting has worsened, rising from 9% to 10.7%, signaling an increase in acute malnutrition. Poor feeding practices are a significant challenge, as only slightly more than one in four children receive adequate nutrition for healthy growth and development. The current economic crisis has exacerbated these issues, disproportionately affecting children and further straining household resources.

The management and allocation of funding for nutrition programs in Lao PDR face significant challenges due to inadequate financial oversight. Nutrition is not designated as a separate sector in the national budget, leading to its funds being dispersed among various sectoral ministries. This fragmentation complicates budget transparency and efficiency, making it difficult to track investments aimed at achieving critical nutrition targets. As a result, nutrition objectives are not effectively integrated into sectoral budget plans or reflected in proposals submitted to the Ministry of Finance. This lack of earmarked and ring-fenced funding creates a major barrier to improving nutrition outcomes.

Current nutrition policies and strategies in Lao PDR also face several shortcomings. The limited integration and coordination across sectors hinder the effective implementation of nutrition interventions. Additionally, the absence of clear budget lines and financial commitments specifically for nutrition makes it challenging to monitor and allocate resources effectively. Existing strategies often fail to address the underlying socioeconomic determinants of malnutrition, reducing their long-term impact.

To address these issues, efficient monitoring and tracking of nutrition investments are crucial. With dwindling resources, improving operational efficiency and effectiveness in strategy is necessary. Evidence-based programming and decision-making are essential for this. The National Information Platforms for Nutrition (NIPN) plays a critical role in this regard by consolidating data from various sectors to support evidence-based policies and strategies. Supported by the EU Delegation and UNICEF, NIPN facilitates multi-sectoral and multi-stakeholder dialogue, contributing to the implementation of the National Plan of Action on Nutrition (2021-2025) and aiming to improve human nutrition through a coordinated, data-driven approach.

UNICEF currently supports the implementation of nutrition programmes in the country using the systems approach. This involves capacitating sectors to design and implement evidence-based nutrition actions across the country. In line with this, UNICEF supports the Socio-economic Policy Research Institute (SPRI), of the Lao Academy of Social and Economic Sciences (LASES) in generating evidence through data analysis and research to influence nutrition policy formulation in the country. This is impacting on planning, budgeting and implementation of nutrition interventions in the country as well as advocacy for an increased public financing in nutrition.

As part of the ongoing system strengthening efforts on policy support, UNICEF seeks to hire an international consultant to conduct regular and ongoing evidence-based policy analysis, strategy development and advocacy in relation to Nutrition.

The Consultant shall be based in Laos at Socio-economic Policy Research Institute (SPRI), Lao Academy of Social and Economic Sciences (LASES) with frequent travel to provincial level. She/he supports various streams of work at the Policy Analysis Unit (PAU), hosted by the SPRI, LASES. The consultant will work closely with the Data Analysis Unit (DAU) hosted by the Development Research Institute (DRI), Ministry of Planning and Investment (MPI) and the UNICEF Nutrition team. This shall include the following:

a. Policy analysis and strategic planning

✓ Provide technical support to the Policy Analysis Unit (PAU) in strengthening stakeholder capacity in nutrition governance, advocacy, policy analysis, financing and evidence-based decision-making.



- ✓ Utilize and update policy landscape analysis of nutrition, existing financial and sectoral programme data to identify gaps and opportunities.
- ✓ Assist the government in prioritize key nutrition issues based on evidence and develop strategic solutions for integration into national and subnational development plans.
- ✓ Support the government in developing a comprehensive resource mobilization strategy, aligned with national nutrition priorities to secure sustainable financial and technical resources for nutrition.
- ✓ Facilitate the nutrition-sensitive policy integration workshop at central level to support the key sectors in the inclusion of nutrition objectives in their broader sector policies and strategies.

b. Advocacy and communication

- ✓ Support the SPRI in design and execute advocacy matrix with targeted audiences for nutrition, focusing on key objectives, messages, channels and desire outcomes.
- ✓ Technical support in producing and disseminating advocacy materials such as budget briefs, infographics, fact sheets, and analytical reports tailored to different audiences.
- Support the government in facilitate regular multi-stakeholder platforms that bring together Government sectors, donors, UN agencies, academia, private sector stakeholders, and civil society to promote inclusive public debates and nutrition policy adoption.
- ✓ Strengthen the capacity of PAU in communicating findings and recommendations to a broad audience, including national and subnational stakeholders, using various platforms to advocate for improved public investments in nutrition.
- ✓ Support the UNICEF nutrition team in conducting targeted advocacy campaigns and preparing for high-level meetings to influence policy makers, emphasizing the importance of nutrition in national development and urging for stronger policies and legislations.

c. Research and evidence generation

- ✓ Support the SPRI in conducting secondary research and generating data on nutrition indicators, policies and budget allocations to inform policy decisions and advocacy efforts.
- ✓ Support the NIPN team in developing and presenting evidence-based recommendations to National Nutrition Committee to address identified nutrition challenges and ensure alignment with national priorities.
- ✓ Assist the PAU in creating knowledge products such as research reports and policy briefs highlighting critical nutrition issues and proposing practical solutions.
- ✓ Support the SPRI in using research findings and data to raise awareness of key budget policies, advocating for inclusive and improved budget, tax policies and public investments in nutrition.

Undertake other relevant tasks to support the work of the Policy Analysis Unit (PAU) as requested by the Head of the PAU and the UNICEF nutrition team.

The consultant will be working from the designated government office at the Socio-economic Policy Research Institute (SPRI), LASES, where she/he will be based for the duration of the assignment.
