II. Organizational Context and Purpose for the job

The fundamental mission of UNICEF is to promote the rights of every child, everywhere, in everything the organization does, in programmes, in advocacy and in operations. The equity strategy, emphasizing the most disadvantaged and excluded children and families, translates this commitment to children's rights into action. For UNICEF, equity means that all children have an opportunity to survive, develop and reach their full potential, without discrimination, bias or favoritism. To the degree that any child has an unequal chance in life, in its social, political, economic, civic and cultural dimensions, her or his rights are violated. There is growing evidence that investing in the health, education and protection of a society's most disadvantaged citizens not only will give all children the opportunity to fulfill their potential but also will lead to sustained growth and stability of countries. This is why the focus on equity is so vital. It accelerates progress towards realizing the human rights of all children, which is the universal mandate of UNICEF, as outlined by the Convention on the Rights of the Child, while also supporting the equitable development of nations.

<u>Job organizational context:</u> The Education Specialist is to be used in a Lubumbashi DRC, covering the provinces of Haut-Katanga, Lualaba and Haut-Lomami, where the Education Programme is a component of the Lubumbashi UNICEF Office strategy which is itself part of UNICEF Country Programme (or UNDAF). The Education Specialist reports to the Chief of Field Office, while maintaining strong technical bound with the Education team based in Kinshasa.

<u>Purpose for the job:</u> Under the guidance and the supervision of the Chief of Field Office, the Education Specialist supports the Education programme and is responsible for managing, implementing, monitoring, evaluating and reporting the progress of education programme. The Education Specialist provides technical guidance and management support throughout the programming processes to facilitate the administration and achievement of results on education programme to improve learning outcomes and equitable and inclusive education, especially for children who are marginalized, disadvantaged and excluded in society.

Context and strategy: The UNICEF programme is implemented in the provinces of Haut-Katanga, Lualaba et du Haut-Lomami. The local context is relatively stable and calls for a developmental response to children's deprivations. The region is characterized by a prominent mining industry which highly influences the life of neighboring communities and conditions of children's development. Despite a booming private sector, the MICS indicators are low and the main problematics affecting children are malnutrition, workforce in dangerous conditions, street children, early marriage and emergency such as cholera and measles. To address those problematics, UNICEF proposes a five parts integrated response: Access to quality basic social services, community of youth mobilization, cash transfer and management, engagement with the private sector and management of protection cases. In each of these responses, the Education programme has a key role to play. For the next few years, the Education programme is expected to step on priority activities such as case management, reduction of violence toward children, youth participation, registration with Civil Status Office, school health, income generating

activities, digital learning, Generation Unlimited, engagement with the private sector, etc. While reaching a large territory, the Education interventions are prioritized toward 10 zones where UNICEF and its partners deliver in an integrated manner in order to maximize the impacts for children.

III. Key functions, accountabilities and related duties/tasks

1. Support to programme development and planning

- Support the preparation, design and updating of the situation analysis for the education programme to ensure that current and comprehensive data on education issues is available to guide UNICEF's strategic policy, advocacy, intervention and development efforts on education programmes.
- Set priorities, strategies, design and implementation plans. Keep abreast of development trends to enhance programme management, efficiency and delivery.
- Participate in strategic programme discussion on the planning of education programmes.
 Formulate, design and prepare programme proposals, ensuring alignment with UNICEF's Lubumbashi strategy, Strategic Plans and Country Programme and coherence/integration with the UN Development Assistance Framework (UNDAF), regional strategies and national priorities, plans and competencies.
- Establish specific goals, objectives, strategies and implementation plans with other sectors using results-based planning terminology and methodology. Prepare required documentations for programme review and approval.
- Work closely and collaboratively with internal colleagues and partners to discuss strategies and methodologies, and to determine priorities to ensure the achievement of concrete and sustainable results.
- Provide technical and operational support throughout all stages of programming processes and to ensure integration, coherence and harmonization of programmes/projects with other UNICEF sectors and achievement of results as planned and allocated.

2. Programme management, monitoring and delivery of results

- Plan and collaborate with internal colleagues and external partners to establish
 monitoring benchmarks, performance indicators and other UNICEF indicators to
 assess/strengthen performance accountability, coherence and delivery of concrete and
 sustainable results for the assigned sector on education programmes.
- Participate in monitoring and evaluation exercises, programme reviews and annual reviews with the government and other counterparts to assess progress and to determine required action/interventions to achieve results.
- Prepare and assess monitoring and evaluation reports to identify gaps, strengths and weaknesses in programme management.
- Identify lessons learned and use knowledge gained for development planning and timely intervention to achieve goals.
- Actively monitor programmes/projects through field visits and surveys, and exchange information with stakeholders to assess progress, identify bottlenecks and potential problems, and take timely decisions to resolve issues and/or refer to relevant officials for timely resolution.
- Monitor and verify the optimum and appropriate use of sectoral programme resources (financial, administrative and other assets) confirming compliance with organizational rules, regulations/procedures and donor commitments, standards of accountability and integrity, ensuring timely reporting and liquidation of resources.
- Prepare regular and mandated programme reports for management, donors and partners to keep them informed of programme progress.

3. Technical and operational support to programme implementation

- Provide technical guidance and operational support to government counterparts, NGO
 partners, UN system partners and country office partners and donors on interpretation,
 application and understanding of UNICEF policies, strategies, processes and best
 practices and approaches on education and related issues to support programme
 management, implementation and delivery of results.
- Arrange/coordinate availability of technical experts with Regional Office/HQ to ensure timely and appropriate support throughout the programming process.

- Participate in education programme meetings including programme development and contingency planning to provide technical and operational information, advice and support.
- Draft policy papers, briefs and other strategic programme materials for management use.

4. Networking and partnership building

- Build and sustain effective close working partnerships with relevant government counterparts, national stakeholders, global partners, donors, and academia through active networking, advocacy and effective communication to build capacity, exchange knowledge/expertise and to reinforce cooperation to achieve sustainable and broad results on education programmes.
- Prepare communication and information materials for CO programme advocacy to promote awareness, establish partnerships and support fund raising for education programmes.
- Participate and/or represent UNICEF in appropriate inter-agency discussions on education and related issues.

5. Innovation, knowledge management and capacity building

- Apply and introduce innovative approaches and good practices to build the capacity of partners and stakeholders and to support the implementation and delivery of concrete and sustainable programme results.
- Keep abreast, research, benchmark, and implement best practices in education management. Assess, institutionalize and share best practices and knowledge learned.
- Contribute to the development and implementation of policies and procedures to ensure optimum efficiency and efficacy of sustainable programmes and projects.
- Organize and implement capacity building initiatives to enhance the competencies of clients/stakeholders to promote sustainable results on education and related programmes/projects.

IV. Impact of Results

The efficiency and efficacy of support provided by the Education Specialist to programme preparation, planning and implementation, contributes to the achievement of sustainable and integrated results. In addition to improve learning outcomes and universal access to quality, equitable and inclusive education, the programme contributes to the reduction of overall vulnerabilities of children. Success in education programmes and projects in turn contribute to maintaining and enhancing the credibility and ability of UNICEF to provide programme services for mothers and children that promotes greater social equality in the country.

VI. Technical Competencies

- Education sector planning knowledge/ability, including the range of modalities for delivering education, linkages between different sub-sectors (e.g. ECD, Primary, Secondary, Tertiary, Inclusive Education), cost-effectiveness and efficiency issues, key institutional structures, components and processes, as well as governance issues.
- Education and policy sector analysis capacity, including understanding of the core education data sets and indicators; tools for analysis of equity; determinants of student access and learning; budget, costing, and financial management in education systems; political economy; and education policy and strategic planning.
- **Programme management in education**, including programme design, costing, monitoring and evaluation and reporting.
- Ability to support engagement with partners e.g. Sector Wide Approaches, Global Partnership for Education, Education in Emergency Clusters, Education Provider Forums, Delivering as One, Inter-sectoral partnerships such as in ECD, as well as networking with other key partners.
- **Understanding of gender and inequity issues** in relation to education and development and the application of gender / equity analysis to policy and planning in education.

VII. Recruitment Qualifications	
Education:	An advanced university degree in one of the following fields is required: education, economics, psychology, sociology, or another relevant technical field.
Experience:	A minimum of five years of professional experience in programme planning, management, and/or research in education is required. Experience working in a developing country is considered as an asset. Relevant experience in a UN system agency or organization is considered as an asset.
Language Requirements:	Fluency in English is required. Knowledge of another official UN language (Arabic, Chinese, French, Russian or Spanish) or a local language is an asset.
