Purpose of Activity/Assignment:					

The main purpose of the assignment is to support qualitative research in Yemen as part of a research study investigating child marriage prevention and response interventions in humanitarian settings in the Middle East. Key areas of support will include collecting, managing and analysing qualitative data; and producing relevant reports and presentations for region and country-level dissemination.

### Background

The UNICEF Innocenti – Global Office of Research and Foresight undertakes high-quality research that contributes to evidence-informed policymaking. Through the STAR (Strategic Technical Assistance for Research) Initiative to end harmful practices, the Child Rights and Protection team at Innocenti aims to strengthen the generation, synthesis, use and uptake of high-quality evidence on harmful practices to inform the work of UNICEF and UNFPA country and regional offices supported by the Global Programme to End Child Marriage and Joint Programme to Eliminate FGM.

The need for rigorous operational research to strengthen intervention design and implementation to address child marriage in the Middle East and North Africa (MENA) region is particularly acute. The MENA region accounts for 45 million women and girls married in childhood. Around 1 in 5 young women were married before 18, and 1 in 25 before the age of 15. Child marriage in the region has been greatly exacerbated by conflict and displacement over the past decade. Despite the severity and extent of the issue, research on child marriage, particularly on interventions, has been notably limited.

While there is anecdotal evidence that child marriage is indeed being addressed in humanitarian contexts, no systematic assessment of the delivery of child marriage prevention and response programing has been undertaken to date. This has led to a lack of awareness about what is happening, where, and how and makes it challenging to design targeted strategies to address child marriage.

To respond, the Child and Adolescent Rights and Empowerment (CARE) Section is implementing a research study to strengthen programmatic responses to child marriage in the region. The aims of the overall study include; assessment of the landscape of interventions to address child marriage in humanitarian settings; examination of the factors perceived to facilitate or hinder the design, delivery and impact of select interventions; and the production of contextualised guidance to strengthen child marriage prevention and response programming in humanitarian settings at the regional and country-level. The overall study will focus its examination of child marriage interventions in five countries in Middle East: Jordan, Lebanon, Syria, Iraq and Yemen. The methodology adopted for this study is adapted from Intervention Mapping (IM), a systematic intervention planning approach designed to guide the design of evidence-based, multi-level interventions grounded in theory and scientific evidence. This study focuses on the foundational step 1 of this approach i.e. a comprehensive situational analysis investigating what is being done programmatically to address child marriage in humanitarian settings in select countries; identify implementation strengths and challenges of select interventions; and the production of contextualised guidance to strengthen the design, delivery and impact of child marriage interventions in each country.

This Terms of Reference seeks a consultant to conduct in-country qualitative research in Yemen, through key informant interviews and focus group discussions; transcribing of data, and data analysis. Additionally, the consultant will support the writing of the report and the production of relevant evidence products (briefs, toolkits/guidance, presentations, and other written materials).

#### **Objectives of the consultancy**

The primary objective of this consultancy is to support the study team in the design and execution of qualitative research focused on Yemen, as part of a regional study investigating child marriage interventions in the Middle East. The main purpose of the assignment is to support qualitative research in Yemen as part of a research study investigating child marriage prevention and response interventions in humanitarian settings in the Middle East. Key areas of support will include collecting, managing and analysing qualitative data; and producing relevant reports and presentations for region and country-level dissemination.

The consultant is required to:

- Review and contribute to an existing mapping and desk review of child marriage interventions in the region with a focus on Yemen
- Review and contribute to qualitative data collection instruments, adapting for local context and stakeholder/informant type and conduct pilot test
- Identify key informants, secure buy-in and liase with them appropriately about time and place for interview in collaboration with the study coordinator
- Conduct in-country key informant interviews and focus groups with programme staff, transcribe verbatim and translate, as required
- Analyse qualitative data from key informant interviews and focus group discussions.
- Produce country-level recommendations to achieve strengthened child marriage programming in collaboration with key stakeholders
- Engage with country and regional office counterparts through the implementation of the research, in addition to country-level stakeholders, such as ministries of education, health, and/or social development and draft briefing notes and presentations.

 In collaboration with the study team, consolidate the research into a regional level report and synthesis with country chapters
