Purpose of Activity/Assignment:

The Child Rights and Protection team at UNICEF Innocenti is seeking a qualified consultant to lead research, technical support and coordination for quality research design and implementation of a range of evidencerelated projects and activities as part of the STAR (Strategic Technical Assistance for Research) Initiative to end harmful traditional practices with a particular focus on child marriage.

Scope of Work:

The UNICEF Office of Research - Innocenti (OoR) undertakes high-quality research that contributes to evidence-informed policy making. Through the STAR (Strategic Technical Assistance for Research) Initiative to end harmful practices, the Child Rights and Protection team at Innocenti, in partnership with the joint UNFPA-UNICEF Global Programme to End Child Marriage (GPECM), aims to strengthen availability of quality evidence on child marriage prevention strategies in 12 participating countries (Bangladesh, Burkina Faso, Ethiopia, Ghana, India, Mozambique, Nepal, Niger, Sierra Leone, Uganda, Yemen and Zambia) and beyond.

As part of the STAR initiative, UNICEF Innocenti is supporting UNICEF and UNFPA country offices in the conceptualization, research design, analysis, writing and dissemination of research studies focused on early, child and forced marriage (hereafter referred to in shorthand as "child marriage") prevention and the needs and rights of adolescents. In addition to providing technical research support to GPECM countries, the STAR initiative also aims to synthesize evidence and respond to critical knowledge gaps in the areas of child marriage and other harmful practices such as FGM.

The Innocenti Child Rights and Protection team is seeking a consultant to lead research, technical support and coordination linked to evidence generation, uptake and use on child marriage and harmful practices for the STAR initiative.

Responsibilities:

- Provide strategic advice and support to GPECM leadership team and Secretariat and country offices including assisting with the prioritization of research studies, advising on/accompanying meetings when necessary, identifying opportunities for the STAR Initiative to support new and planned studies.
- Lead activities across the STAR Initiative's workstreams:
 - 0 Support GPECM countries in high-quality evidence generation: a) Provide hands-on guidance and technical research support to current GPECM priority research studies (including research focus, design implementation and analysis, review of research concept notes, literature reviews, TOR, protocols, questionnaires, training materials and study results; b) engage with GPECM countries periodically to identify further countries and new studies requiring technical support; c) Manage the STAR initiative, coordinating additional Innocenti researchers providing support, and identifying and overseeing appropriate technical support to country studies

- Coordinate evidence synthesis to respond to knowledge gaps: a) Oversee the development and implementation of an evidence synthesis plan including systematic and scoping reviews and evidence summary briefs that synthesize evidence on key topics linked to ending harmful practices; b) Support translation of available evidence into policy and programmatic recommendations; and c) Support the establishment and updating of global database of child marriage research
- Coordinate research uptake and use, and related capacity strengthening activities: a) Support planning and execution of learning clinics and country and regional workshops to share evidence; b) support global, regional and national dissemination events and discussions on available evidence on effective strategies for ending child marriage and other harmful practices.
- Coordinate with the UN Joint Programme to end FGM to identify rollout and support for research strategy as appropriate and relevant.
- Overall management of the STAR initiative including: creating visibility for project progress and milestones through regular documentation and internal communication; contributing to budget oversight and donor reporting as required; providing regular updates and organizing meetings as required of the informal governance/advisory structure supporting the initiative; working as a liaison and partner with UNICEF Innocenti researchers, GPECM Secretariat, and UNICEF and UNFPA HQ, regional and country offices to deliver effective evidence support

Duration of the consultancy:

The consultant will work <u>full-time</u> over a period of 6 months (total of 108 working days, 18 days per month), with a starting date planned of 17th January 2022.

Supervision and work arrangements:

The consultant will be working remotely and will report to the Chief, Child Rights and Protection and work closely with the GPECM Secretariat
