PURPOSE OF THE ASSIGNMENT

To provide the technical assistance needed by the Ministry of Primary and Secondary Education (MoPSE) and stakeholders in appraising the soundness, relevance, and coherence that form the credibility of ESSP 2021-2025 based on the characteristics defined in the GPE/IIEP Guidelines for Education Sector Plan Appraisal and help development partners to ensure the robustness and credibility of the Plan and its M&E framework.

BACKGROUND

The MoPSE with the support of the partners has started drafting of the Education Sector Strategic Plan (ESSP) 2021-2025 after the expiry of the ESSP 2016-2020. The ESSP 2021-2025 is preceded by an Education Sector Analysis 2020. The ESSP 2021-2025 is also largely be influenced by the national economic blueprint, the National Development Strategy 1 (NDS1) 2021-2025. The ESSP 2021-2025 will be the third ESP developed by Zimbabwe after the Education Medium Term Plan 2011-2015 and the ESSP 2016-2020. These plans helped shape the education landscape that was devasted by the socio-economic and political challenges of 2008 that saw the sector regress and schools literally close. The coming up with Education Sector Plans has made the sector coordinate its activities based on carefully planned indicators with achievable targets. There has been great improvement in enrolments, reform of the curriculum, improved policy enactment and implementation and improved learning outcomes. Out of these two plans, MoPSE benefited from the Global Partnership of Education's Education Strategic Plan Implementation Grants (ESPIGs).

Over the years, education in Zimbabwe has suffered from underfunding and internal inefficiencies.

The Ministry of Primary and Secondary Education (MoPSE), as set out in the TORs of the ESSP consultancy came up with a Core Technical Team (CTT) derived from the MoPSE which would work with the Technical Assistance Team (TAT) derived from the consultancy. The purpose of coming up with a CTT was to have the process become a country- led process with the Ministry in the lead and partners receiving update through the Local Education Group locally known as the Education Coordination Group. The ESSP 2021-2025 was expected to have been completed by the end of 2020. However, the process was delayed by the challenges brought about by the Covid 19. The was renewed effort to ensure that the ESSP 2021-2025 is completed by the second quarter of 2021.
