Duty Station: Srinagar, J&K **Contract Duration:** 36 months **Closing Date:** 25th April 2023

1. BACKGROUND / RATIONALE

UNICEF child protection Section is working in Jammu and Kashmir (J&K) since 2014. UNICEF has successfully invested in technically supporting the Government of J&K in creating child protection structures in J&K for the last eight years. These structures deliver the service in the form of care and protection of children, juvenile justice, appropriate care options and bringing in a strong Mental Health Psychosocial Support (MHPSS) for children especially in 10 districts of Kashmir. However, the structures and resources are not calibrated to deliver the much-needed Mental Health Psycho- Social Support (MHPSS) for children especially a bare minimum service like counseling and allied support services like various remedial services, therapies, psycho education enabling children to have basic knowhow of standard dos and "don'ts" in addition to basic awareness about the existing Mental Health Psychosocial Support (MHPSS) in their districts/communities. The child protection cadre in the UT needs guidance, handholding, mentoring and skills development which shall be the key role of UNICEF with the Government in the coming years. As per the draft State Action Plan between UNICEF, Government of J&K and High court of J&K there will be enhanced support to technical agencies like Government Medical College's (GMC) Institute Of mental Health and Neuro-Sciences (IMHANS), GMC-Jammu and other relevant duty bearers to support the child protection system enabling it to deliver quality child protection services with focus on Mental Health Psychosocial Support (MHPSS) to the children.

The early identification and timely interventions can have a major impact on the mental health outcomes of children experiencing mental health issues. Given the increasing incidence of neuro-developmental disorders (like autism, ADHD), self-harm, substance abuse, learning disabilities and other mental health issues providing an early intervention is highly needed.

Due to the availability of limited MHPSS services in Kashmir region, there is a huge treatment gap. The study "Mental health illness in the valley" conducted by Action Aid and IMHANS in 2015 indicated that only 6.4% of the persons experiencing mental health issues had received treatment by a qualified mental health professional. The study also indicated that the reasons for low treatment levels were because of high stigmatization of mental health issues, very low awareness about mental health issues, and inaccessible treatment at the community level, as most mental health services available in Kashmir are in urban areas.

To improve access of children and adolescents to mental health services on timely basis, there is a need for strengthening comprehensive community-based and district level services. That will enhance outreach, ensure the active involvement of communities' and families; make mental health services more acceptable and deliver the services fast in cost effective manner. Such models are also cost effective and scalable, and promote mental health, reduce stigma, and build social support for people experiencing mental health issues.

Therefore, we will require a consultant who will contribute to quality program delivery by providing and demonstrating technical support, handholding, monitoring and guidance to key government and CSO partners This will help in quality results for children, proper fund utilization, and enhance the capacity of the implementing partners on child protection issues and protection-related programming. The consultant will work hand in hand with the IPs to support in the effective and efficient delivery of MHPSS program. The assignment will capture bottlenecks in programme implementation and propose solutions to overcome the identified bottlenecks.

2. PURPOSE OF ASSIGNMENT

Provide and demonstrate technical support, handholding and monitoring of the implementation of the MHPSS programme in Jammu & Kashmir.

3. OBJECTIVES

The consultant will be constantly working on the identification of mental health gaps and challenges, drafting of set of recommendations for Implementing Partners (IPs), and following up for effective implementation of an identified solution to address the gaps.

The consultancy is related to the increased focus to programming in J&K build on last year's work in the area of preventive community-based child protection mechanisms with focus on Community based child protection work including the child friendly spaces and especially work on PSS. It is expected that the consultant will support the outpost section CP J&K for technical support in strategizing the planning, implementation and monitoring of the programme activities in the UT of J&K.

4. MAJOR TASKS AND ACTIVITIES TO BE ACCOMPLISHED

The consultant will be involved mainly on below mentioned major tasks:

Planning:

- i. To support incorporating MHPSS components in Child Protection Program.
- ii. To support in finalization and implementation of detailed implementation plan on MHPSS.
- iii. To undertake extensive review-based assessment of MHPSS work and submit a strategic plan for MHPSS with focus on community based MHPSS.

Technical support to CFS/ARC community-based Child Protection Program especially in PSS for children:

- i. To provide regular and timely coordination of various partners for the successful roll out of the new program components in the selected districts.
- ii. To provide technical assistance in integrating referral systems/mechanisms to address the issues of the most vulnerable children/adolescents/youth with respective services.
- iii. Coordination of various training program by IMHANS and GMC-Jammu for front line workers, contribution to their content and delivery design.
- iv. Coordination with other line departments (Social Welfare, health, education, ICPS, police and district administration)
- v. Overall monitoring of the program implementation, as per program document.
- vi. Consolidate inputs and provide the required reports and documentation

Co-ordination support:

- i. Provide assistance to coordinate the implementation of the new program components in Jammu & Kashmir especially the work on psychosocial support.
- ii. Assist partners in implementing the program for strengthening community-based child protection program with increased focus on psychosocial support, youth engagement, Child-friendly Spaces/ARC's and provide support for coordination between the various agencies
- iii. Coordination with various agencies including DCPU and the District Social Welfare officials, DMHP, CWC, JJB, etc.

Monitoring, and Documentation:

- i. Jammu and Kashmir based program monitored for the quality of implementation and suggesting corrective measures suggested.
- ii. Regularly update the program related data through monitoring of programme activities
- iii. Consolidate required inputs from across partners for the CP activities

Scope of Work:

- 1) To strategize a multi sectoral Mental Health Psychosocial Support (MHPSS) program with focus on community based MHPSS and mainstreaming it in existing system like Child Protection, Education and Health.
- 2) To provide support for planning, implementation, monitoring and quality assurance of the Mental Health Psychosocial Support (MHPSS) program in Kashmir division and Jammu division as well. This would

- primarily include oversight of the partnerships with main implementing partners IMHANS, GMC-Jammu, and NGO partners and relevant Government departments.
- 3) To travel extensively to program implementation sites to monitor the quality of program implementation and suggesting corrective measures.
- 4) To provide technical assistance to the implementation of program, monitoring and reporting.
- 5) To advocate with the district /state stakeholders for replication of MHPSS model.
- 6) To support the implementing partners in replication of MHPSS program for children and adolescents in identified districts by working closely with the district administration, community, and other stakeholders.
- 7) To provide handholding support to IPs in identifying and addressing the implementation gaps in their MHPSS activities.
- 8) To bring systematic and periodic review for quality results/progress of Child protection programs implemented/rolled out in partnership with various govt. and CSO partners.
- 9) To provide on-field handholding support to partners and key government functionaries to improve implementation of various MHPSS program related activities.
- 10) To address the bottlenecks, challenges and errors emerging during the implementation of MHPSS program.

The consultancy is related to the increased focus to programming in J&K build on last year's work in the area of preventive community-based child protection mechanisms with focus on Community based child protection work including the child friendly spaces/adolescent resource centers and especially work on MHPSS. It is expected that the consultant will support the outpost section CP J&K for technical support in strategizing the planning, implementation and monitoring of the programme activities in the UT of J&K.

Minimum Qualifications required:

An advanced university Masters' degree is required in Psychology, Social Work, Sociology or Psychiatry or any other relevant field.

- a. At least 6 years of relevant professional experience implementing initiatives in the areas of health, mental health, public health.
- b. Thorough understanding of the concepts and implementation of Government's MHPSS programs and initiatives in Jammu & Kashmir
- c. Experience working in a humanitarian emergency is an asset.
- d. Preference will be given to candidates with experience of working in coordination with government, UN agencies and CSOs.
- e. Excellent analytical and report writing skills.
- f. Good computer skills, at least of MS-Office application software (MS Word, Excel, Power Point) and internet applications.
