Background and Justification

UNICEF recognizes adolescent girls and boys as sources of opportunity rather than of problems; “at promise” rather than “at risk.” The fulfilment of their rights requires an investment in their development and their capacity at different stages to acquire critical assets; the abilities and skills, values and experiences to negotiate multiple life domains, to avoid risky behaviors and become economically independent. A positive development approach considers adolescents girls and boys as assets and seeks to empower them to participate in an active way within their families and communities.¹ Programming for and with adolescents has been growing exponentially in the past two decades in UNICEF country offices. The new Strategic Plan consolidates existing investments in and accelerates the visibility of adolescents throughout the organization – across sectors, in expanded partnerships, through media and communication and in research, monitoring and evaluation.²

There are currently 6.3 million adolescents in Yemen (10-19 years) which represents more than 21.55 % of the total population³. This population is expected to continue to grow over the next 30 years almost doubling by 2050⁴. These changing demographics present opportunities that should be planned for in advance of the realization of the potential demographic dividend.

There are enormous gaps and challenges in terms of realizing the full potential of adolescent boys and girls in Yemen. The eruption of the conflict in March 2015, and its continuation to date, has created an unprecedented humanitarian crisis in Yemen affecting almost all of Yemen’s 22 governorates as continued airstrikes, shelling and ground fighting have resulted in significant destruction of civilian infrastructure including schools, hospitals, roads and bridges, whilst the lack of public sector salaries has led to a collapse of public systems and services. Even prior to the conflict, Yemen already had some of the worse indicators in the region for children, adolescents and particularly girls, in a context of limited access to resources and services and harmful socio-cultural norms and practices

Keeping a regularly updated Situation Analysis on adolescent and youth (SitAn) is central to UNICEF mandate. It contributes to inform national strategies, policies and programmes, and orient them towards actions which aim at accelerating the progress on child rights-related national goals and promoting a broad engagement of stakeholders.

Given the situation in Yemen and since that conducting a situation analysis could not be feasible, UNICEF Yemen Country Office is embarking on conducting a rights-based and equity-focused desk review on Adolescents and Youth in Yemen to contribute to the generation of knowledge and identification of critical gaps to serve as a basis for evidence-based policy and programming for adolescents and youth. The findings are also aimed at guiding stakeholders in the identification of programmes and interventions.

Purpose of Activity/Assignment:

The purpose of the exercise is to conduct a rapid desk review of key publications and documents on Adolescents and Youth (A&Y) in Yemen, which will consist of:

- Conduct a comprehensive and evidence-based desk review on A&Y. The desk review shall follow a holistic approach and consider the cross-sectoral areas of: demographic trends, health and nutrition, education, school to work transition and economic empowerment (covering life skills), care and protection, and disability, with a focus on gender and equity to ensure that the most vulnerable groups are considered;
- Map current response/interventions to A&Y by different stakeholders in Yemen including policies, programs, and services.
- Take stock of the available data and identify gaps in research, studies, and evidence to inform the adolescents programming across sectors (Health, Education, Child Protection...etc.) and identification of gaps in policies specifically related to A&Y in Yemen; and of “legislative and country governance bottlenecks” and also “system bottlenecks in some sectors”.
- Recommendations to fill in the gaps of (i) data collection, (ii) developed of policies including processes and (iii) researches.

Work Assignment- Specific Tasks to be completed:

Review key documents, strategies and reports produced by UNICEF, UN agencies, World Bank, League of Arab States, Population Council, and other relevant documents to produce a document outlining the situation of A&Y in Yemen, with focus on the following themes:

- Listing of Vulnerable A&Y: living in poverty, Juvenile, and disability
- Gender/Equity lens, child marriage and all forms of harmful practices
- Education (formal/information, access and quality)
- Employability and social entrepreneurship: Livelihoods and economic participation
- Adolescent health and wellbeing
- Civic engagement and participation
- A&Y affected by conflict (CAAC, displacement, refugee status, migration issues/trends, social cohesion) and, issues of security, stability and radicalization of A&Y.

Methodology

The methodology will consist of a thorough analysis based on existing data. The desk review will involve all relevant sectors to A&Y development: education, skills development, employment, health, nutrition, protection, participation and civic engagement. The exercise will identify and collect all available data across the sectors, existing laws, policies, and regulations, pertaining to adolescents and youth’s development.

Key Questions to be answered

The desk review will respond to the following questions, either through direct consideration, or through reference to other documents in which these are adequately addressed:

1. What is the situation of adolescents and youths in Yemen from 2015 till now, and how has it evolved? (Progress and challenges)
2. Which are the most deprived groups of adolescents and youths? Where are they located?
3. What forms of deprivation, exclusion, and the patterns are for multiple deprivations and where they intersect? What are the determining factors that give rise to and perpetuate their exclusion?
4. How do the duty bearers (national authorities, UN, Civil Society, NGOs) respond to the gaps in adolescents and adolescents and youths’ rights in Yemen? What is the status of public policies and public and private social interventions affecting adolescents and youths in Yemen?
5. What risks (conflict, natural hazards, etc.) exist that are likely to affect the patterns of deprivation and exclusion?

6. What programme interventions and resource mobilization and allocation options are currently available or should be considered in the future, to address specific dimensions of inequity and pervasive vulnerabilities?
