The WASH section, UNICEF East Asia and Pacific Regional Office (EAPRO) is seeking an individual consultant to provide technical support in the implementation of the WASH in Emergencies (WiE) programme, including WASH response to the COVID-19 pandemic in the East Asia and the Pacific Region (EAPRO).

Background:

The East Asia and the Pacific region is one of the most disaster prone regions in the world compounded by the outbreak of a novel corona virus in late 2019 that gradually evolved into a global pandemic affecting lives and global economy. The pandemic has forced governments to resort to a total or partial lockdown to contain the virus from further transmission. This situation has affected the normal delivery of UNICEF WASH programme and demanded a huge surge in escalating hygiene promotion in the region as handwashing with soap has proved to be very effective in minimising the risk of transmission. As such, national WASH and health systems are facing the challenges to protect communities, school children, patients in hospitals, health care and other treatment/isolation/quarantine centres as well as general public and provide essential WASH supplies for minimising the mortality and morbidity related to COVID-19. Similarly, the schools have remained closed since the outbreak in many countries in the region with gradual opening affecting the learning environment and outcomes for many children in the region.



UNICEF Regional Office has been providing support to country offices since late January 2020 in strengthening WASH response to the pandemic. The initial WASH Regional Preparedness and Response actions have been centred around three priority areas:

- Strengthen risk communication and community engagement to ensure children, women and other vulnerable groups have access to accurate information on prevention and assistance is critical to minimizing the impact of 2019-nCoV;
- Infection Prevention and Control to provide technical support and guidance to government to develop and implement guidance on IPC; develop and deliver IPC trainings to frontline workforce; and support the implementation of IPC SOPs in health, education and protection facilities;
- Procure and provide critical hygiene and prevention supplies to schools, health facilities and public spaces and rehabilitate handwashing stations in vulnerable communities that have poor WASH facilities and infrastructure; and
- Enhance WASH programme to ensure that communities, schools and health care facilities have access to life saving WASH supplies for practicing hand hygiene and that schools, health care facilities adopt adequate WASH protocols to ensure safe return to schools, workplaces and in the publica spaces.

With the launch of global guidance on WASH programming in response to COVID-19 as well as the launch of "Hand Hygiene for All" in line with the 3R framework of Respond, Rebuild and Reimagine, all UNICEF EAP country programmes are expected to align their Response Plans to include three critical pillars/areas of response: i) Hygiene programming to prevent human to human transmission, ii) WASH & Infection Prevention Control and iii) Continuity of Essential WASH Services and Product Supply Chains. Technical support in the implementation and monitoring of CO emergency response plans, as well as in documenting lessons learned from the implementation, is the critical component of the RO WASH team's workplan.

Purpose of Assignment:

To support UNICEF EAPRO and country offices in the region with the technical expertise to strengthen WASH in emergency preparedness and response to disasters as well as COVID-19 pandemic and increase the visibility on UNICEF's response through development of WASH response dashboards at the regional and country levels as well as documentation of high-quality knowledge products in the region for global and regional learning.

The core objectives of this consultancy are as follows:

- 1. Support to strengthen Humanitarian WASH response for COVID 19 and other emergencies in UNICEF and with Partners in the region;
- 2. Support to strengthen WASH4Work agenda in the region in the context of COVID-19 and 'Safe return to work'; and
- 3. Support in strengthening Knowledge Management of WASH humanitarian response including COVID-19 and other disasters in the region.

Work Assignment, Deliverables, and Work Schedule:

Under the guidance of Regional Adviser WASH, the consultant will work under the direct supervision of WASH Specialist and perform the following tasks:

To qualify as an advocate for every child you will have...

- Advanced University Degree in Civil Engineering, Economics, Development, Humanitarian Response, Disaster Management, Communication, Computer Science, Social Science, Information Management or related disciplines.
 - A first university degree may be accepted in lieu of an advanced university degree with additional qualifying experience.
- Minimum 5 years of progressively responsible relevant experience in the field of WASH, WASH in emergencies (WiE), including Disaster Risk Reduction (DRR) and Climate Change Adaptation (CCA). Experience in complex emergencies strongly preferred.
- Experience with proven record of knowledge management in development programmes, especially on sanitation and hygiene, water quality and safety and cross-cutting areas including gender, disability, adolescents, etc. will be an additional asset.
- Technical experience and knowledge in the area of WASH in emergencies response required, including monitoring and evaluation, supply management and partnership coordination.
- Previous experience editing and writing for UNICEF and familiarity with UNICEF's style guidelines would be an asset.
- Sound interpersonal and communication skills, including experience in cross-cultural environment and international settings.
- Familiarity and relevant work experience in the East Asia and Pacific region is an asset.
- Proven ability for accuracy under pressure and adherence to deadlines.
- Demonstrated ability to work independently, take initiative and innovate.
- Fluency in English is necessary. Knowledge of any other languages spoken in the region would also be an advantage.
- Willingness to be based in Bangkok, Thailand once COVID-19 travel restrictions are lifted.
