Purpose of Activity/Assignment:

The purpose of this consultancy is to support the implementation of social protection interventions which are integrated within a multi-sectoral project, which include a variety of programme / sectors (education, child protection, social protection, and SBC) aimed at achieving education outcomes for children. Under the direct supervision of UNICEF Social Policy Section, the Cash Plus Consultant will work and collaborate with our partner the Social Welfare Fund (SWF), to deliver and carryout the proposed social protection interventions (cash plus) as part of the integrated ECHO project funded by ECHO in Hodeidah governorate within Bajil district.

Background/ Scope of Work:

Throughout this integrated/multi-sectoral project, UNICEF aims to address the diverse barriers related to education by targeting children at the age of school (official age), including children at risk or drop out of schools/education, with focus on the most vulnerable, poorest, and marginalized groups from economically challenging background, and people with disabilities. The project will be implemented by UNICEF Hodeidah Field Office (FO), in close collaboration with UNICEF' Social Policy Section at the Country Office, in partnership with government counterparts (MoE, MOSAL, SWF etc.)

As part of this project, the proposed social protection activities include a vulnerability need assessment to support us assess, prioritize, and select targeted beneficiaries eligible for cash transfer/plus interventions, with a focus on the most vulnerable children and their families. The cash transfer/plus program is intended to motivate and support the most vulnerable and underprivileged families in enrolling and promoting children's access to and retention in education (primary and elementary schools). Cash plus approach will be delivered thru a case management and referral modality, as well as SBC key messages carried out by SWF at a household-level to selected children and their families.

Purpose of the consultant's assignment:

The Consultant will be responsible of coordinating and providing technical guidance and capacity building training to the Social Welfare Fund (SWF) on cash plus programme, particularly the data information system and APP utilized to deliver and manage the Cash transfer / plus's case management and referral, and the vulnerability assessment. The selected consultant will be collaborating and working closely with the SWF' program & technical team in Hodeidah and Sana'a. Furthermore, the consultant shall coordinate and collaborate with UNICEF Hodeidah FO (education, child protection and SBC sectors and team) who are involved in implementing the multi-sectoral project funded by ECHO.

UNICEF is looking for a consultant with at least two years of experience in social protection, specifically Cash Plus programming and approaches, including program guidelines and implementation modalities (case management and referral). The selected candidate shall possess proven expertise in program design, information management, and analysis, with technical expertise and knowledge on Power BI to utilize and shape data and create interactive visuals for the cash plus program, while also demonstrating relevant experience on MIS/APP such as (ODK, InForm, and Activity Info) for gathering, managing, generating,



reporting, and analyzing data collected throughout the cash plus's case management / referral, as well as the household vulnerability need assessment.

Under the SP section guidance and supervision, the consultant will supervise the CashPlus MIS (creating the necessary data infrastructure for beneficiary database, producing, and sharing real-time dashboards and reports about the progress in cash plus, as well as providing technical guidance and specific trainings on cash plus MIS to the SWF' CM team and enumerators, along with collaborating closely with the SWF' IMO team).

Below are the key technical responsibilities and tasks which needs to be delivered by the consultant:

1. Vulnerability needs assessment (beneficiary verification for Cash Plus):

- a) Design, develop and maintain a comprehensive database and MIS for the vulnerability assessment's data collection tools and storing platforms, using an electronic APPs (KOBO ODK InForm).
- b) Generate the list of children's parents (HH) to be assessed via a household vulnerability need assessment.
- c) Coordinate and deliver capacity building training to SWF team on vulnerability need assessment; data collection tools, forms, and questionnaire (APP).
- d) Ensure quality of data collected throughout the vulnerability assessment.
- e) Supervise the cash transfers/plus's beneficiary verification and enrollment process; by reviewing, validating, cleaning, and addressing mistakes, duplications, or coding errors in data collected thru vulnerability assessment.
- f) In collaboration with the SP section and SWF; design and produce a MIS data analysis tool for prioritizing, categorizing, and verifying data collected from targeted HH, according to the multi-dimensional poverty indicators and measurement methods set in line with the Cash plus's beneficiary criteria.
- g) Generate the beneficiary database of prioritized and selected children's parents / HH, who will be enrolled for cash transfer / cash plus.
- h) Develop and produce statistical, and dashboards reports from the data collected thru the vulnerability assessment, that includes supporting the SP section with any data related requirements such as (developing fact sheets, and narrative report)

2. Cash Plus (case management and referral):

- a) Update and produce the Cash plus "CM and referral" MIS system (APP) used for data collection tools / templates & reporting.
- b) Ensure referral pathways are updated and reflected in the MIS APP based on approved mapping services, defined protocols, agreed-upon service providers.
- c) Ensure that the CM and referral developed APP is in line with the SP and SWF' data protection procedures.
- d) Provide capacity building trainings for SWF team on the CashPlus data information (APP).
- e) Collaborate with the SP Officer to ensure that the Cash Plus's indicators are well monitored and reported.
- f) Produce and share dashboards via PowerBI for the CashPlus interventions (Case Management need assessment, awareness activities/SBC, referral to services, follow up process and closure of cases) as requested/needed "daily, monthly, weekly, or quarterly".
- g) Ensure data availability and accuracy related to cash plus "CM and referral": (by undertaking regular field monitoring visits to verify the accuracy and reliability of data and provide all necessary technical support for SWF to enhance and maintain data quality and integrity).
- h) Generate data updates & dashboards for cash transfer interventions (payment cycles), in close coordination and collaboration with the YSC.
- i) Prepare monthly, quarterly and final progress reports on the cash transfer / cash plus to be used in (HPM Reports and donor reports).

Expected Deliverables & Timeframe:

This is a 6-month consultancy that will support UNICEF in achieving the SP proposed objectives within the ECHO project. The selected consultant will be based in Hodiedah (70%) and Sana'a, with 30% of the consultancy assignment/duration dedicated to supporting and working with the SP section and SWF HQ in Sana'a. The selected Consultant needs to deliver and achieve the following deliverables, within the agreed-upon time frame of the consultancy contract period, as per the ToR classification.



- MIS data information management (electronic APPs) developed & utilized by vulnerability assessment and Cash plus's case management & referral.
- List of verified beneficiaries for cash transfer/plus is generated and shared via the FTPS server using the desired form/template inquired by YSC.
- Field programmatic monitoring visits conducted to monitor the cash plus implementation in Bajil district.
- Technical guidance and capacity-building provided in a timely and quality manner to the SWF technical team.
- SWF is supported to generate monthly reports (disaggregation data reports, statistical and dashboards) for cash transfer / plus (CM / referral), including vulnerability assessment.
- Regular or monthly meetings updates with the SP officer and chief of field office on the progress made during the consultancy period.
- A comprehensive final report for achievements, challenges, recommendations, and lessons learned concerning

The financial proposal should specify a total lumpsum amount and payment terms shall be in line with those that are mentioned in the deliverable table below.
