#### **Background of Request for Individual Contractor:**

The overall purpose of UNICEF China's Social Policy programming is to ensure that fewer children in China are subject to multidimensional poverty, through being better able to access affordable social protection mechanisms and quality social services. This will allow children's rights to be protected – particularly the most vulnerable and those lagging behind - to better achieve their educational potential, be guaranteed of improved health outcomes, and assume their role as productive members of their society, community and family in the rapidly transforming environment in China.

The Social Policy Section of UNICEF China has been long working with Government of China (GoC) particularly the National Development and Reform Commission (NDRC) to uphold child rights in the delivery and uptake of the essential social services. In recent years, the two sides have broadened the scope of collaboration and joined hands in an emerging area-child friendly cities (CFC). GoC's commitment to CFC has been factored into the 14<sup>th</sup> Five-Year Social and Economic Development Plan (FYP) in March 2021, in which building CFC has been articulated as an essential service for children. In line with the 14<sup>th</sup> FYP and the Guiding Opinion of Promoting the Building of CFC, UNICEF will continue to strengthen its partnership with the government counterparts and other stakeholders on:

- Generating evidence to improve the policy and technical frameworks of China's CFC development
- Establishing a capacity building framework on CFC to empower, guide and support subnational stakeholders' actions of moving toward CFC
- Developing platforms to strengthen and harness the technical support and advising capacity of experts and other technical players.
- Organizing public advocacy, communication, and public engagement activities to raise awareness and facilitate public participation on CFC
- Facilitating international exchange and collaboration on CFC, in particular actively supporting China's global sharing of CFC knowledge and experience
- Introducing global good practice especially related to urban planning and placemaking and providing more hands-on support to grass-root players

All the work above requires considerable technical support especially through working with national and subnational experts, which is beyond the capacity of our current staffing. The Social Policy Section therefore requires a full-time individual contractor with the related technical expertise and experiences, who can provide technical support to the national and subnational policy making and advocacy activities for CFC development.



### **Purpose of Assignment:**

- 1) To provide technical and coordination support for the evidence generation activities related to CFC development
- 2) To provide technical support and coordination for capacity building framework
- 3) To provide technical inputs to urban planning related activities and help build up in-house know-hows on urban planning
- 4) To support the stakeholder engagement activities for the related policy advocacy including but not limited to organization of meetings with GoC and other partners, conducting research work in line with the project objectives, and etc
- 5) To prepare memos/drafts/briefs for the UNICEF/GoC reporting
