# BACKGROUND

Climate shocks contribute significantly to humanitarian needs and lead to poverty and food and nutrition insecurity, in addition to health and longer-term recovery challenges. Nigeria is regularly affected by multiple hazards, such as floods. Due to climate change, the intensity and frequency of floods have increased over the years, with Nigeria having experienced the most devastating floods in a decade in 2022. Low-income households are the most vulnerable to natural disasters. In 2016, the Nigerian government rolled out a comprehensive National Social Safety Net Programme (NASSP). In view of mitigating the impact of climate shocks on vulnerable families, UNICEF leverages the opportunities of the National Social Safety Net Programme to strengthen the shock-responsive nature of the social protection system via the engagement of all relevant stakeholders.

# How can you make a difference?

Under the general supervision of the Emergency Manager, the Programme Specialist – Humanitarian Cash Transfers and Shock-Responsive Social Protection, will build on the lessons learned from an anticipatory action pilot carried out in Kaduna State in Northwest Nigeria in 2022 by rolling out a cash preparedness initiative in Jigawa State, also in Northwest Nigeria.

The Programme Specialist shall also provide strategic guidance to enable the country office to engage relevant national and local authorities in view of strengthening the government's shock-responsive nature of social protection systems. Finally, the Programme Specialist

Summary of key functions/ accountabilities:

1. **Project Design and Coordination**: Serves as project coordinator of the cash preparedness interventions in Jigawa State, Northwest Nigeria, as well as other humanitarian cash transfers or shock-responsive social protection interventions as applicable; and is responsible for the intervention design, management of implementing partner (contract and tracking of timely and quality deliverables), project planning and



implementation via updated project workplan, monitoring of programme/ project activities, data analysis and documentation of lessons learned, donor reporting, accountability to affected populations (AAP) in cash interventions, and facilitate the publication of learning on project outcomes.

2. **Monitor cash-related budgets** and ensure that all budgeted resources are requested, disbursed, utilized, and reported in accordance with the implementation timelines and commitments.

3. **Provide strategic guidance** in close coordination with the Social Policy Section, to enable the country office to engage all relevant government authorities, in view of strengthening the government's capacity at federal and state level to operationalize shock-responsive social protection.

4. **Ensure internal coordination and mapping** of humanitarian cash transfers and shock-responsive social protection initiatives across the country office as needed. In support of the Social Policy Section, contribute to the development of the country office cash strategy.

5. **Strengthen fundraising**, by drafting donor proposals to expand the country office's operational footprint on humanitarian cash transfers and shock-responsive social protection, and build and maintain partnerships with cash transfer and social protection experts among Member States.

6. Inter-agency participation in cash transfer and shock-responsive social protection fora, such as the National Cash Transfer Working Group, and the Northwest Cash Working Group: Actively participate in interagency fora to advance the sector's knowledge and ability to effectively address vulnerable people's needs via the strengthening of national systems where possible.

7. Track the risk management components of cash transfers, in close coordination with the social policy, supply, and finance sections of the country office. Garners thereby the opportunities of the country office's recent establishment of the Humanitarian Cash Operations and Programme Eco-System (HOPE) – UNICEF's Management Information System for cash transfers to individuals. Also, ensure that applicable Harmonized Approach to Cash Transfers (HACT) risk management measures are implemented, and coordination with relevant teams, explore efficiencies where possible.

8. Follow and enhance learning of the country office, by following global and regional initiatives and innovations on humanitarian cash transfers and shock-responsive social protection. Identify cash-related bottlenecks and provide solution options to the manager.

9. Undertake field visits as needed to monitor humanitarian cash transfers, and thereby ensure accountability.

10. Perform other duties within reason, as needed.

#### To qualify as an advocate for every child, you will have...
