Purpose of Activity/Assignment:

The nutrition situation in Lao PDR remains concerning, with key indicators showing minimal improvement. Stunting rates among children have remained stagnant, from 33% in 2017 to 32.8% in 2023, reflecting persistent issues with chronic undernutrition. Wasting has worsened, rising from 9% to 10.7%, indicating an increase in acute malnutrition. Poor feeding practices are a significant challenge, as only slightly more than one in four children receive adequate nutrition for healthy growth and development. The current economic crisis has further exacerbated these issues, disproportionately affecting children and straining household resources.

In addition to these nutrition challenges, there are significant issues with data management and its use for decision-making. The existing information systems for nutrition, which support planning and monitoring at both national and subnational levels, suffer from poor data quality. Problems such as incomplete, inaccurate, and inconsistent reporting undermine the reliability of nutrition indicators, across key sectors, complicating effective planning and monitoring. The provincial and district authorities face notable difficulties due to insufficient capacities for data analysis and use, hindering their ability to derive actionable insights from the data.

To address these issues, it is crucial to enhance the quality of nutrition data and improve its utilization for decision-making. Strengthening information systems, increasing local capacities for data analysis and ensuring accurate and consistent reporting are essential steps. These improvements will support better planning, monitoring, and evaluation of nutrition programs, ultimately leading to more effective interventions and improved nutrition outcomes in Lao PDR. The National Information Platforms for Nutrition (NIPN) brings together data from relevant sectors for analysis to support evidence-based policies and programmes to improve human nutrition as well as facilitate multi-sectoral and multi-stakeholder dialogue on nutrition. It is an international initiative of the European Commission and an integral part of the government's nutrition programme, which is supported jointly by the EU Delegation and UNICEF as their contribution to the implementation of the National Plan of Action on Nutrition (2021-2025).

UNICEF currently supports the implementation of nutrition programmes in the country using the systems approach. This involves capacitating sectors to design and implement evidence-based nutrition services across the country. In line with this, UNICEF supports the Development Research Institute (DRI), of the Ministry of Planning and Investment (MPI) in generating evidence through data analysis to influence nutrition decisions and actions in the country. This is impacting on planning, budgeting and implementation of nutrition interventions in the country as well as advocacy for an increased public financing in nutrition.

As part of the ongoing system strengthening efforts on evidence generation, UNICEF seeks to hire an international consultant to enhance skills and systems at both national and subnational level to improve the multisector coordination, planning, implementation and monitoring of nutrition programmes. This role involves providing technical support, building local expertise and ensuring effective use of data to drive evidence-based decisions and actions.

The Consultant shall be based in Laos (Development Research Institute, MPI) with frequent travel to provincial level. She/he supports various streams of work at the Data Analysis Unit, hosted by the Development Research Institute (DRI), Ministry of Planning and Investment. The consultant will work closely with the Policy Analysis Unit hosted by the Lao Academy of Social and Economic Sciences and the UNICEF Nutrition team. This shall include the following:

a. Technical support and capacity strengthening

- ✓ Design and deliver training programmes, workshops and hands-on technical assistance to enhance the capacity of Government sectors for evidence-based decisions at national and subnational levels.
- Conduct training sessions to build stakeholder capacity in accurate nutrition data collection and quality assurance across sectors.



- Offer ongoing support to stakeholders for robust analysis of nutrition data using standardized tools and methodologies.
- Conduct secondary research and utilize existing data to complement primary data sources, enhancing the overall depth
 of nutrition insights.

b. Multi-sectoral nutrition programme analysis

- Conduct comprehensive analysis of nutrition data across Health, Agriculture, WASH, Education, Social Policy and other sectors to identify trends and gaps.
- ✓ Support provinces in developing multi-sector nutrition dashboards based on sectoral key indicators for nutrition.
- ✓ Document best practices, success stories, lessons learned and areas needing improvement in sectoral data management and use.
- ✓ Develop and present policy recommendations based on data-driven insights to address identified gaps in nutrition programs.

c. Support provinces for multi-sector planning and reporting

- ✓ Assist provincial teams in integrating nutrition objectives, targets and indicators into provincial sectoral plans that align with national strategies.
- ✓ Provide guidance to provinces for reporting and tracking of nutrition indicators of the National Plan of Action for Nutrition (NPAN)
- ✓ Work with stakeholders to ensure that nutrition objectives are embedded within broader socio-economic planning and budgeting processes at central and subnational levels.

d. Stakeholder engagement and knowledge management

- ✓ Support the DRI in engaging various stakeholders, including Government sectors, Donors, UN agencies, CSOs, Academia and Private sectors, to enhance coordination in nutrition data management and use.
- ✓ Promote the use of data-driven insights in policy and programme development to ensure nutrition interventions are informed by the best available evidence.
- ✓ Support the SPRI in organizing and leading workshops and seminars to share best practices, disseminate lessons learned and foster continuous learning across sectors, utilizing the NIPN website, dashboards and other digital platforms.

Undertake other relevant tasks to support the work of the Data Analysis Unit as requested by the Head of the Data Analysis Unit and UNICEF
