Purpose of Activity/Assignment:

Objective:

- To curate a powerful and creative exhibition display for UNICEF Zambia for the 75th anniversary of UNICEF in November-December 2021.

Background:

In 2021, UNICEF commemorates 75 years as the leading organization working for every child. This critical moment in our history, together with our partners and supporters, we will reimagine the future for every child:

- Leverage UNICEF's history, experience and vision at a critical moment in time
- Express our DNA and the unique role we play on priority issues
- Reinforce our equity message – for every child
- Support and strengthen current and future partnerships

With both the annual anniversary of the UNCRC celebrated as World Children's Day falling on 20 November, and the UNICEF anniversary on 11 December, many country offices will plan activities to mark both moments through this period.

UNICEF Zambia is looking for a curator to research, coordinate and put together a powerful physical factual exhibition for a venue in Lusaka that will, in a creative way, chart the themes of:

- How childhood has changed in Zambia over the past 75 years
- UNICEF's work over the years in Zambia, referencing also global institutional history

The curation work will build on existing work by researchers, but will include i) suggestions for displays and the coordination of the same, ii) assembly and presentation of material iii) additional research, iv) writing of content v) work with graphic designs as part of a wider team vi) propositions for the launch event.

Overall, these will both tell the story of childhood development in Zambia over the past 75 years, but also highlight powerful stories of how UNICEF interventions have helped children along the way.
