Background:

Support the Education programme implementation of initiatives under the EU integration, specifically catchup learning, digitalization and STEM education, in Poltava office area of responsibility.

Purpose of assignment:

Under the general guidance and supervision of the Education Officer in UNICEF Poltava, and in close oversight of UNICEF Kyiv's Education Section, the consultant will be responsible for providing technical guidance, expertise and coordination, delivering education activities related to UNICEF programmes, focusing on catchup, EU integration related education activities. The consultant will support national-level initiatives in education under the EU integration initiative, specifically in priority territorial hromadas of the recovery interventions.

Summary of key functions/accountabilities:

- The Consultant will communicate regularly with partners in the field and update the UNICEF team, and direct supervisor on the overall progress of programme implementation, achievements, and constraints.
- The Consultant will identify knowledge and skills gaps among educators involved in catch up learning programmes implemented by the partner and suggest training themes for future consideration, multisectoral cooperation, and deepening the knowledge and skills of professionals across sectors.
- The Consultant will provide regular updates on programme progress in Poltava and Sumy Oblasts and will be responsible for collecting data and regular reporting, including draft briefs, reports, and inputs to programme materials. The Consultant will work closely with and under the supervision of the UNICEF Team.
- Desk review of catch-up learning approaches in Poltava and Sumy oblasts



- Adapt the MoE's recommendation on catch-up learning using the DLC/Students Learning Support Centres and other Education Centres projects in Poltava and Sumy oblasts.
- Providing technical assistance for strengthening a safe and accessible approach to catch—up learning using the DLC sites.
- Build the capacity of the school administrations of the DLC schools in Poltava and Sumy.
- Baseline and final assessment of school performance in terms of catch-up learning.
- Adapt and further develop the MDLC approach under the DLC project sites (MDLC Multi-Disciplinary Learning Centre; DLC Digital Learning Centre).
- Support in coordinating with stakeholders, contractors and implementing partners involved in the development of digital education content creation and activities implementation.
- Support in developing regular updates on the activities and results of the digital education and catch-up learning programme milestones.
- Providing technical assistance for developing activities to better prepare for youth-related labour market insertion in line with EU skills and qualification policies and EU Employment Strategy and in context of emerging trends of digitalization and STEM education using the MDLC approach.
- Provide monitoring and reporting support to UNICEF implementing partners and donors.
- Support development and delivery of relevant, robust, innovative and continued competency-based teacher and school leaders training to help mitigate learning losses in various learning environments.
- Perform other related duties and assignments as and when required.

It is expected for the incumbent to work remotely, participation in all meetings and activities to be ensured via online tools. However, it is also expected travelling to Poltava or Sumy Oblast in case of events. In this case UNICEF covers the travel and accommodation costs (round trip, meal and accommodation costs

The consultant will support the project with the following contributions:

- In coordination with UNICEF staff, support to prepare all relevant catch-up learning documents and ensure compliance of Poltava office education projects with the MoE's recommendations on catch-up and national catch-up strategy;
- Analyze global, regional and national best practices in digitalization of education, provide technical
 assistance for developing activities to use MDLCs to their full potential to ensure quality results in
 catch-up learning and young people skills development.
- Providing monitoring of Poltava FO education programmes to ensure they are in line with EU skills and qualification policies and EU Employment Strategy.
- Provide technical support, guidance, and advice to Poltava FO Education Officer in terms of catch-up, digitalization of education and EU integration in education;
- Closely follow up the integration of catch-up component into project planning and implementation.

Project Management and Implementation

- Identify challenges, opportunities, priorities and needs for the development and implementation of the catch-up learning activities and children and youth wellbeing activities;
- Make sure that the catch-up learning project implementation in DLCs/MDLCs/Students Learning Support Centres in Poltava and Sumy is in line with MoE's recommendations on catch-up and national catch-up strategy;
- Provide technical support during project implementation to ensure compliance to the MoE's recommendations on catch-up and national catch-up strategy;



• Take stock of lessons learned from previous projects on catch-up, global, regional and national best practices, and current UNICEF and MoE guidelines and procedures to ensure catch-up learning programmes developed and implemented within the project remain up to date and current.

Project Monitoring & Reporting

- Undertake follow up monitoring to ensure that proposed catch-up programmes are implemented according to the national standards;
- Ensure monitoring tools are developed, applied and reported to ensure compliance of catch-up activities;
- Reporting of all risks and concerns observed on the ground to UNICEF education programme.
