Individual National Consultancy: Support to the Independent Appraisal of Lao PDR's 9th Education and Sports Sector Development Plan (ESSDP)

#### **Terms of Reference**

## 1. Background:

The Lao PDR Ministry of Education and Sports (MoES) is developing the 9<sup>th</sup> Education and Sports Sector Development Plan (ESSDP) covering the period 2021-2025. The development of the new sector plan comes as Lao PDR is nearing the end of the current Education Sector Development Plan 2016-2020. A mid-term review of the current plan was completed in 2018 with the report used as reference for the development of the 9<sup>th</sup> ESSDP.

The 9th ESSDP will align with the Lao PDR 9th National Socio-Economic Development Plan (NSEDP) 2021-2025, which is currently being developed. The 9th ESSDP will also align with the Sustainable Development Goals (SDGs), in particular SDG 4 on education, and other international commitments of the Government of Lao PDR. The Lao PDR MoES initiated the process to develop the new ESSDP in mid-2019, adopting a participatory approach, which has envisaged the participation of stakeholders at national and sub-national levels, including development partners.

An Education Sector Working Group (ESWG), the equivalent of a Local Education Group, has been set-up in Lao PDR. The ESWG has a two-tiered structure providing a platform for senior officials and technical staff of MoES and development partners to shape the 8th ESDP, monitor its progress, provide guidance and support the mid-term review and the implementation of the recommendations from the review. The ESWG has also continued to serve as a platform for highlevel and technical engagement, both from MoES and development partners in the preparation of the 9th ESSDP. An ESWG Secretariat is in place under the leadership of the Department of Planning.

To guide 9th ESSDP development, MoES has had several internal consultations with relevant subsectors and line departments, and has engaged provincial, district and school-level education stakeholders. Development Partners, which include representatives from bilateral and multilateral institutions, UN agencies, INGOs, NGOs have also been engaged via the ESWG mechanism. A series of workshops and consultations were conducted in November 2019 with various education subsector stakeholders. Inputs and data collected from these consultations are currently being consolidated into the draft ESSDP. Consultants supported by development partners – Australia, the European Union (EU) and UNICEF – are providing technical assistance to the MoES throughout this process.

As a Global Partnership for Education (GPE) developing country partner, Lao PDR has received financial and technical assistance in developing education sector plans and to implement the sector plan. Lao PDR plans to apply for a GPE grant to support the implementation of the 9<sup>th</sup> ESSDP. The Lao PDR Education Support Program Implementation Grant (ESPIG) proposal to GPE will apply for both regular and multiplier funding, beginning after May 2021. GPE requires an independent appraisal of the draft ESSDP.

## 2. Purpose:

Following a request from the Ministry of Education and Sports (MoES), UNICEF is hiring an international consultant to carry out the independent appraisal of the draft  $9^{th}$  ESSDP. The independent appraisal, to be coordinated with key development partners, is expected to start in early March 2020 and be completed by mid-May 2020.

The key objective of this consultancy is to support the coordination for the independent appraisal of the 9<sup>th</sup> ESSDP and to provide support to the international consultant, including translation and interpretation support during meeting and field visits.

# 3. Work Assignments:

Specific tasks for this consultancy are:

- Coordinate with the MoES, the Education Sector Working Group (ESWG) Secretariat, and key Development Partners in setting up meetings as part of the 9th ESSDP appraisal
- Collect and compile all relevant documents needed by the international consultant as part of the appraisal
- Provide translation support (summary) in relation to key documents
- Provide translation/interpretation support during meetings, consultation workshops and focus group discussions as part of the appraisal
- Support the organization of field visits (at least 2) for the appraisal in coordination with MoES, UNICEF and other key Development Partners

# 4. Qualifications or Specialized Knowledge/Experience Required:

- A university degree in education or related field;
- Working experience in the education sector of at least 2-3 years an advantage;
- Similar work experience in other sectors an advantage

- Knowledge of Lao PDR and local context
- Demonstrated understanding of education sector planning and program implementation, an advantage

#### **Competencies**

- Demonstrates strong oral and written communication skills in English and Lao language
- Communicates, works and networks effectively with a wide range of people to reach broad consensus on a well-coordinated response, and demonstrates leadership where required
- Ability to work collaboratively with counterparts in government ministries and at the local/school levels

#### **Languages**

• Excellent verbal and written English and Lao language skills.

Vientiane, Lao PDR with travel to provinces

#### 6. Duration:

Starting early March 2020 to early April 2020

The consultancy is expected to be up to 23 working days. It will involve travelling to at least two provinces.

#### 10. Administrative Issues:

The consultant will be based at the UNICEF Lao PDR Office with significant amount of time spent in the Ministry of Education and Sports and meetings with key Development Partners. The consultant will be provided with work space in the UNICEF Lao PDR office. The consultant is expected to provide his/her own computer for the duration of the assignment.

# 11. Contract supervisor:

UNICEF, as requested by the MoES and agreed to by the ESWG, will manage the work of the consultant and ensure coordination with the MoES and ESWG. For administrative purposes, the Education Specialist of UNICEF Lao PDR will supervise the work of the consultant, in close consultation with the Chief of Education. The consultant will work in close collaboration with the MoES and Development Partners coordinated by the ESWG Secretariat.

### 12. Nature of 'Penalty Clause' to be Stipulated in Contract:

Unsatisfactory performance: In case of unsatisfactory performance the contract will be terminated by notification letter sent five (5) business days prior to the termination date in the case of contracts for a total period of less than two (2) months, and ten (10) business days prior to the termination date in the case of contracts for a longer period

Performance indicators: The consultant's performance will be evaluated against the following criteria: timeliness, quality, and relevance/feasibility of recommendations for UNICEF Lao PDR.

# 14. Assessment Criteria:

A two-stage procedure shall be utilized in evaluating proposals, with evaluation of the technical component being completed prior to any price proposal being compared.

Applications shall therefore contain the following required documentation:

- 1. Technical Proposal package, including a cover letter, updated CV, and copies of 2 relevant performance evaluations.
- 2. Financial Proposal: Lump-sum offer with the cost breakdown: Consultancy fee, travel costs (economy class), per-diem to cover lodging, meals, and any other cost related to the consultant's stay in the provinces. The travel (if involved) shall be based on the most direct and economy fare.

No financial information should be contained in the technical proposal.

NOTE: For evaluation and selection method, the Cumulative Analysis Method (weight combined score method) shall be used for this recruitment:

Technical qualification (max 100 points), weight: 70%

- Education (15 points)
- Relevant work experience, including examples of part work (45 points)
- Competences, knowledge and skills (40 points)

Financial proposal (max 100 points), weight: 30%

The maximum number of points shall be allotted to the lowest financial proposal that is evaluated and compared among those technical qualified candidates who have attained a minimum 60 points score in the technical evaluation. Other financial proposals will receive points in inverse proportion to the lowest price.

The contract shall be awarded to the candidate obtaining the highest combined technical and financial proposal, subject to the result of a verification interview.
