Subject / Title: Consultancy to developing preschool educational pedagogical coaching handbook

Expected start date: May 15, 2019

Duration: 7 months

Supervisor: Education Specialist

1. Background

The Early Childhood Care and Education (ECCE) services in China have been rapidly expanding since 2010, as the State Council issued its landmark 'Guiding Opinions on Pre-School Education'. A major challenge in this context is how to ensure expansion with quality. With the implementation of the three terms of the 3-year action plans (2010-2012) and huge investment from the central and local governments to expand ECE services in the rural areas, thousands of kindergartens and preschools have been set up; many teachers were newly recruited or transferred from primary schools to staff the kindergartens and preschools. This rapid change in access raised the issue of quality of service delivery. UNICEF has been working with government counterparts to develop and promote the implementation of quality related guidelines, such as the Early Learning and Development Guideline. However, it needs to be supported by more practical, and cost-effective models of quality kindergarten services, and the staff working with children urgently require capacity development on what makes for a good kindergarten that is nurturing and that provides opportunities for children's physical and psychological development.

Teacher's pedagogical coaching activities are regarded as an effective way to build up teachers' professional capacity. In 2018, the Chinese Government issued a policy documents <Some opinions on deepening the reform and standardization of preschool education>. In this policy, it emphasized the importance of improving the preschool education pedagogical coaching system through strengthening the kindergarten based and regional based kindergarten teachers' pedagogical coaching "However, in China, there is no existing guidance or handbook to guide local ECD focal points or kindergartens on how to do pedagogical coaching activities and activities often turned out very low efficiency and could not resolve teachers' questions, especially in the rural areas. Therefore, there is urgent need of writing up a handbook of preschool education pedagogical coaching activities handbook which could be used by ECD project focal points or kindergartens in UNICEF pilot areas to do their own pedagogical coaching activities with high quality, so that to promote their teaching quality and sustain the quality improvement, and potentially benefiting more teachers and children beyond UNICEF programme through professional exchange activities.

The services of a consultant are required to undertake the writing up this handbook.

2. Purpose of the Consultancy

The purpose of the consultancy is to develop a handbook on preschool educational pedagogical coaching activities handbook.



3. Expected results:

This handbook includes the general principles and methods of conducting pedagogical coaching activities, but also ten important kindergarten quality theme which ECD focal points or kindergartens could follow step by step in their own contexts. This handbook need a rural perspective.
