Background:

Ukraine is the second-largest country in Europe, with an estimated population of 44 million prior to the escalation of the war with the Russian Federation. Ukraine is in the third year of the escalation of the full-scale war – a war which has eroded the progress made by Ukraine and reversed human development gains, causing significant civilian casualties, the largest mass displacement in Europe since World War II, and demographic shifts with dire implications for the country's recovery and long-term development. As at March 2024, the UN verified that since the start of the war: 600 children in Ukraine have been killed and 1,357 have been injured, with explosive weapons causing 87 per cent of child casualties; 34 per cent of 6.5 million refugees are estimated to be children; 3.7 million people remain internally displaced in Ukraine; approximately 630,000 displaced children have returned to their place of origin; and approximately 700,000 children live in temporarily occupied areas along the front lines, experiencing intense shelling and severe constraints to basic needs (for further reference: SitRep mid-year 2024).

Additionally, UNICEF Ukraine is finalizing its cooperation cycle in 2024 and planning the new one for 2025. As a result, the Office is under high demand for producing plans and reports. Therefore, additional support is required for the end-of-year report to advance the compilation and editing tasks of the narrative versions prepared by various Programme Sections, including Field Offices. This support will help ensure the consistency and coherence of the report and facilitate writing that effectively highlights UCO's results.

Purpose of Activity/Assignment:

Goal and Objective: Under the overall guidance of the Chief Planning, Monitoring, and Reporting of UNICEF Ukraine, the consultant will support UNICEF Ukraine in compiling, reviewing and copy editing the 2024 Country Office Annual Report, including the Country Office Summary Narrative and Results Assessment Module (RAM) reports, assuring the highest quality as per the UNICEF guidelines including the Style Guide.

Main Duties and Responsibilities:



- 1. Support UCO Sections and Field Offices in producing end-year narrative reports through guidance and organization in writing, with a focus on results.
 - Review the annual report guidelines.
 - Produce a timeline for each milestone.
 - Coordinate with PMR on actions and revisions for the various parts of the report, ensuring consistency and coherence.
- 2. Perform substantive writing and editing by:
 - Ensuring consistent style of writing and tone throughout the reports.
 - Correcting spelling, punctuation, grammar, and syntax mistakes and eliminating repetition and ensuring a concise way of writing.
 - Consolidate and produce a write-up based on content inputs and data provided by UNICEF Ukraine.
- 3. Results Assessment Module Reports (RAM)
 - Edit Results Assessment Module (RAM) reports from each section to ensure coherence and results are clearly and effectively articulated.
- 4. Country Office Summary Narrative Report
 - Compile, review and edit the draft inputs from Programme Sections, Field Offices, and Operations to produce the draft Summary Narrative.
 - The situational analysis section should be written based on the edited annual RAM reports and draft inputs from Programme Sections.
 - The Summary Narrative Report content should be in line with the global Specific Guidelines for Country Office Annual Reports.
