- Conduct Needs Assessments and Problem-Fit Assessments that are data-driven, leveraging our dynamic mental health innovation landscaping and horizon scanning, to inform resource allocation and solution effectiveness.

- 7. Engage youth directly in the development and scaling of mental health solutions, leveraging Systems Innovation methodologies to explore roles that UNICEF and local innovation ecosystems can play.

## To qualify as an advocate for every child you will have...

- An advanced university degree (Master's or higher) in psychology, Public Health with a focus on Mental Health, psychiatry, or a related field. \*A first University Degree in a relevant field combined with 5 additional years of experience in public mental health services, including field experience in crisis settings may be accepted in lieu of an Advanced University Degree.
- A minimum of five years' professional experience in managing complex projects; with demonstrated ability for creative thinking and innovative approaches, preferably with experience in design thinking, prototype development and implementation of innovation.
- Established connections within UNICEF and wider United Nations innovation ecosystems.
- Experience or demonstrated capability in engaging with youth or youth-centric programs.
- Developing country work experience and/or familiarity with emergency context is considered an asset.
- Fluency in English is required. Knowledge of another official UN language (Arabic, Chinese, French, Russian or Spanish) or a local language is an asset.

## **Travel:**
