Individual International Consultancy: Data Analysis and Report on the national Disability Identification Data

1. Background

In 2016, the Ministry of Social Affairs, Veterans and Youth Rehabilitation (MoSVY) launched disability identification for Disability Allowance Programme that is poverty-targeted and focused on the poor households with persons with disabilities identified through a functional questionnaire administered by trained commune/sangkat focal points. However, the coverage of the Disability Allowance Programme remained low due to outdated data collection method and overall low capacity of the commune focal points to undertake proper disability identification.

In 2020, MoSVY has launched the national Social and Rights-Based Disability Identification mechanism for all people with disability in Cambodia, using digitalized data collection approach implemented by trained commune/sangkat focal points, with data management established through web-based Disability Management Information System (DMIS). This has resulted in more than 200,000 of people with disability identified. The disability identification data will be used for the targeting of the social assistance programmes, particularly the Cash Transfer Programme for Persons with Disabilities envisaged under the recently developed Family Package Programme.

Given that this is the first national disability identification process undertaken at this scale in Cambodia with an on-demand mechanism established for future identification, there is a need to analyze the currently collected data to improve knowledge on the status of persons with disability in Cambodia for programming, policy and advocacy purposes.

2. Purpose

The purpose of the consultancy is to expand the availability of information on the characteristics of persons with disability (PwD) in Cambodia to inform policy and programme design.

The consultancy is ultimately to result in a report analyzing the types and levels of disability and profiles of persons with disability following the social and environmental dimensions/variables contained in the data set. The data set to be analyzed is derived from the administrative data collected by MoSVY through the disability identification mechanism rolled out in 2021, including data on 240,000 individuals. The report will highlight regional and any other considerations of relevance to the persons with disability in general and/or specifically in relation to social, medical and environmental dimensions contained in the identification methodology/questionnaire with an additional objective to allow for the development of the reporting framework to be updated by MoSVY on a regular basis. Given that the identification methodology allows for collection of data for children 0-8 years of age, profile of children with disability will be presented separately. To the

extent possible and where necessary, the consultant will draw on existing analysis and information on persons with disability in Cambodia and where applicable draw reference to other countries.

Detailed PwD identification questionnaires are presented in the Annex of the TOR.

3. Work Assignment

- Prepare a consultancy work-plan and the proposed format of the report in consultation with the MoSVY Disability Welfare Department and UNICEF.
- Develop a data analysis framework and data matrix following indicators in the identification questionnaires.
- Prepare report, including summary of key highlight of the analysis
- Prepare presentation and summary factsheet for dissemination of the report
- Develop the reporting framework, including key indicators, to allow for regular updating by MoSVY adjusted to the current capacities and provide capacity building for MoSVY staff on the data analysis and data generation to allow for the updating using e-format.

15. Assessment Criteria

A two-stage procedure shall be utilized in evaluating proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared.

Applications shall therefore contain the following required documentation:

- Technical Proposal, including a cover letter, updated CV, and copies of 2 relevant evaluations performed earlier by the consultant. No financial information should be contained in the technical proposal.
- Financial Proposal: Lump-sum offer with the cost breakdown: Consultancy fee, health insurance, and miscellaneous.

The Cumulative Analysis Method (weight combined score method) shall be used for evaluation and selection in this recruitment:

- a) Technical Qualification (max. 100 points) weight 70 %
 - Relevant Education Degree(s) (30 points)
 - Experience in similar assignments, research and data analysis (40 points)
 - Experience in preparing similar report (30 points)
- b) Financial Proposal (max. 100 points) weight 30 %

The maximum number of points shall be allotted to the lowest Financial Proposal that is opened /evaluated and compared among those technical qualified candidates who have attained a minimum 70 points score in the technical evaluation. Other Financial Proposals will receive points in inverse proportion to the lowest price.

The Contract shall be awarded to candidate obtaining the highest combined technical and financial scores, subject to the satisfactory result of the verification interview.]
