# II. Organizational Context and Purpose for the job

The fundamental mission of UNICEF is to promote the rights of every child, everywhere, in everything the organization does — in programmes, in advocacy and in operations. The equity strategy, emphasizing the most disadvantaged and excluded children and families, translates this commitment to children's rights into action. For UNICEF, equity means that all children have an opportunity to survive, develop and reach their full potential, without discrimination, bias or favoritism. To the degree that any child has an unequal chance in life — in its social, political, economic, civic and cultural dimensions — her or his rights are violated. There is growing evidence that investing in the health, education and protection of a society's most disadvantaged citizens — addressing inequity — not only will give all children the opportunity to fulfill their potential but also will lead to sustained growth and stability of countries. This is why the focus on equity is so vital. It accelerates progress towards realizing the human rights of all children, which is the universal mandate of UNICEF, as outlined by the Convention on the Rights of the Child, while also supporting the equitable development of nations.

#### Job organizational context:

Non-communicable diseases (NCDs) are a growing threat to children and adolescents and NCDs contribute significant disease burden among children in countries at all levels of development and in particular in the 5-19 age group. UNICEF-Bangladesh will leverage its' existing partnership with MOHFW to improve national health systems, specifically through our work within the primary health care system, which will ultimately support to further strengthen the existing child health programme integrating a broad range of NCDs among children. UNICEF will work with the partners to reduce NCD risk factors, advocate around NCD prevention and control efforts, strengthen primary health care and referral facilities to manage chronic conditions, and empower local communities to generate demand and create public accountability around NCD interventions during the new CPD 2022-2026.

Adolescent Health is one of the priorities in UNICEF new country program 2022-2026. In this backdrop, Adolescent health has been an emerging priority and calls for 'Promoting gender-responsive adolescent health and hence, UNICEF Bangladesh has supported the Government of Bangladesh through its' Ministry of Health and Family Welfare to design and implement a comprehensive gender-responsive adolescent health program in collaboration with different stakeholders. Mainstreaming the adolescent health programme in Bangladesh would require further strategic and technical leverage from UNICEF and other development partners.

The Health Officer- Child NCD and Adolescent Health is positioned in the Health Section of Bangladesh Country office to manage and monitor the Child Health, Non-Communicable Diseases (NCD) and Adolescent Health programme of UNICEF-Bangladesh under the direct supervision of Health Specialist-Maternal and Adolescent health.

Purpose for the job: The Health Officer reports to the Health Specialist- Maternal and Adolescent Health under

the technical guidance of the Health Manager-MNCAH and Chief for supervision. The Health Officer provides professional technical, operational and administrative assistance throughout the programming process for the Health Programme within the Country Programme particularly on the child health including Non-Communicable diseases (NCD) and adolescent health, from development planning to delivery of results, by preparing, executing, managing, and implementing a variety of technical and administrative programme tasks to facilitate programme development, implementation, programme progress monitoring, and evaluating and reporting of results.

### 1. Support to programme development and planning

- Conduct and update the situation analysis for the development, design and management of health related programmes particularly on the child health including Non-Communicable diseases (NCD) and adolescent health. Research and report on development trends (e.g. political social, economic, health) for higher management use to enhance programme management, efficiency and delivery of results.
- Contribute to the development and establishment of sectoral programme goals, objectives, strategies, and results-based planning through analysis of health needs and areas for intervention and submission of recommendations for priority and goal setting.
- Provide technical and operational support throughout all stages of programming processes by executing and administering a variety of technical programme transactions, preparing materials and documentations, and complying with organizational processes and management systems, to support programme planning, results based planning (RBM), and monitoring and evaluation of results.
- Prepare required documentations and materials to facilitate the programme review and approval process.

#### 2. Programme management, monitoring and delivery of results

- Work closely and collaboratively with colleagues and partners to discuss operational and implementation issues, provide solutions, recommendations, and/or to alert appropriate officials and stakeholders for higherlevel intervention and decisions. Keep record of reports and assessments for easy reference and to capture and institutionalize lessons learned.
- Participate in monitoring and evaluation exercises, programme reviews and annual sectoral reviews with government and other counterparts to assess programmes and to report on required action/interventions at the higher level of programme management.
- Monitor and report on the use of sectoral programme resources (financial, administrative and other assets), and verify compliance with approved allocation and goals, organizational rules, regulations, procedures, as well as donor commitments, standards of accountability, and integrity. Report on issues identified to ensure timely resolution by management and stakeholders. Follow up on unresolved issues to ensure resolution.
- Prepare regular and mandated sectoral programme/project reports for management, donors and partners to keep them informed of programme progress.

## 3. Technical and operational support to programme implementation

#### Health Officer, NOB (post no. 98704)

- Conduct regular programme field visits and surveys, and share information with partners and stakeholders to
  assess progress and provide technical support and/or refer to relevant officials for resolution. Report on critical
  issues, bottlenecks and potential problems for timely action to achieve results.
- Provide technical and operational support to government counterparts, NGO partners, UN system partners, and other country office partners/donors on the application and understanding of UNICEF policies, strategies, processes, and best practices on health-related issues to support programme implementation, operations and delivery of results.

## 4. Networking and partnership building

- Build and sustain effective close working partnerships with health sector government counterparts and national stakeholders through active sharing of information and knowledge to enhance programme implementation and build capacity of stakeholders to deliver concrete and sustainable results.
- Draft communication and information materials for CO programme advocacy to promote awareness, establish partnerships/alliances, and support fund raising for health programmes.
- Participate in appropriate inter-agency (UNCT) on health programmes to collaborate with inter-agency partners/colleagues on UNDAF operational planning and preparation of health programmes/projects, and to integrate and harmonize UNICEF's position and strategies with the UNDAF development and planning process.
- Research information on potential donors and prepare resource mobilization materials and briefs for fund raising and partnership development purposes.

## 5. Innovation, knowledge management and capacity building

- Identify, capture, synthesize, and share lessons learned for knowledge development and to build the capacity of stakeholders.
- Apply innovative approaches and promote good practices to support the implementation and delivery of concrete and sustainable programme results.
- Assist with oversight of research and ensure results are available for use in knowledge products.
- Participate as a resource person in capacity building initiatives to enhance the competencies of clients and stakeholders.

# IV. Impact of Results

The efficiency and efficacy of support provided by the Health Officer to programme preparation, planning and implementation facilitates the delivery of concrete and sustainable results that directly impact the improvement of the health of the most marginalized and vulnerable women and children in the country.
