# II. Organizational context and purpose for the job

UNICEF's strategic focus on adolescents, and especially girls, within the Water, Sanitation, and Hygiene (WASH) sector aligns with its broader goals to empower young people as agents of change, as highlighted in the UNICEF Strategic Plan 2022–2025. The Global Communication and Advocacy Strategy 2019–2021 underscores the necessity of involving young people in developing solutions and promoting meaningful engagement opportunities. Strategic shifts in WASH include making programs climate-resilient, aiming for universal sanitation and hygiene access, scaling up WASH in schools and healthcare facilities, linking emergency needs with sustainable solutions, and strengthening enabling environments. Goal Area 4 of the Strategic Plan emphasizes equitable access to WASH services, system strengthening for gender-equal and sustainable services, and climate-responsive programming, particularly benefiting disadvantaged and fragile communities. By focusing on these areas, UNICEF aims to ensure that adolescent girls have access to safe water and sanitation, recognizing their critical role in driving progress towards the Sustainable Development Goals (SDGs).

#### **Organizational context**

The Adolescent Girls in WASH and Institutions Specialist is reporting to the Chief of the WASH section. The Specialist will lead the revision of the WASH program, incorporating a gender transformative approach and addressing adolescent needs and roles, while assisting with JMP data collection and dissemination, engaging partners, developing a strategic vision and fundraising plan, and driving initiatives on menstrual health management and sexual and reproductive health and rights.

## Purpose of the job:

This role will strengthen the capacity of the WASH section in the Madagascar country office to develop, implement and monitor effective and engaging advocacy campaigns involving young people with a gender transformative lense. Under the leadership of the Chief of the WASH section the role will be responsible for supporting the development and implementation of youth advocacy campaign strategies; identifying partnership opportunities; developing and disseminating campaign content; monitoring and reporting on campaign results; advising on ways to grow UNICEF's advocacy and youth engagement; and providing creative engagement

opportunities and reaching new audiences through partnerships for WASH. The WASH Specialist will also be in charge of WASH activities in Institutions (schools and health centers) from data collection and analysis to project management and fundraising.

## Roles and Responsibilities:

As an Adolescent Girls Specialist in WASH and Institutions, this staff member will drive transformative change by actively engaging youth in WASH initiatives, advocating for their rights, and fostering their inclusion in decision-making processes. They will mobilize young people to amplify their voices in support of children's rights, promote adolescent inclusion in WASH programming, and prioritize adolescent needs in emergency response efforts, thus advancing sustainable and equitable access to WASH services in institutions.

## 1. Youth Engagement Strategy Development and Implementation:

Develop and implement robust youth engagement strategies with SMART outcomes and compelling calls to action; including social marketing and choice architecture.

- Conduct political, economic, and cultural trend analysis, audience analysis, and market research to identify opportunities and challenges.
- Propose innovative approaches as part of the strategy development process.

## 2. Programme Development and Planning:

- Draft WASH inputs for the situation analysis, focusing on WASH in Institutions and adolescent inclusion.
- Provide data to inform WASH policy and programme development, planning, management, and implementation.
- Participate in strategic WASH programme planning discussions and prepare donor proposals aligned with UNICEF's strategic plans and government priorities.
- Formulate WASH outcome and output results, related indicators, baselines, and targets using mWater as the data management tool.
- Collaborate with colleagues and partners to discuss strategies and methodologies for achieving WASH output results.

## 3. Youth, adolescents and Children Engagement and sensitivity:

 Design and implement effective communication plans to mobilize young people for the promotion of cvchildren's rights causes.

- Provide technical guidance on content moderation, community management, and content creation for youth-focused digital platforms.
- Establish/strengthen child and youth-friendly feedback mechanisms for in and out-ofschool youth and children to engage them in the provision of quality services

## 4. Programme Management, Monitoring, and Delivery of Results:

- Strengthen national government WASH sector monitoring systems for institutions, harmonizing data collection tools at the national level, paying particular attention to JMP monitoring and reporting.
- Strengthen community-level mechanisms to ensure youth and children's participation in tracking processes and indicators of change
- Participate in monitoring and evaluation exercises, programme reviews, and annual sectoral reviews with government and counterparts.
- Prepare and assess monitoring and evaluation reports to identify programme strengths and weaknesses, document lessons learned, and prepare progress reports for management, donors, and partners.

#### 5. Technical and Operational Support for Programme Implementation:

- Monitor UNICEF-supported activities through field visits, surveys, and partner exchanges to assess progress and resolve issues.
- Provide technical support to government counterparts, NGO partners, UN system
  partners, and donors on UNICEF policies and best practices, especially for adolescent
  inclusion in WASH programming.
- Draft policy papers, briefs, and strategic materials for use by management, donors, and UNICEF regional offices and headquarters.

## 6. Humanitarian WASH Preparedness, Response, Recovery, and Reconstruction:

- Assist with requisitions for supplies and services to ensure preparedness for WASH commitments in emergencies, focusing on institutions and adolescent inclusion.
- Provide support to the cluster in designing preparedness, response, and recovery plans that include adolescent and children's considerations and sensitivity.
- Support partners in ensuring effective implementation of the humanitariandevelopment nexus; including integrated peace-building initiatives with a special focus on children, adolescents, and youth

#### 7. Networking and Partnership Building:

- Build and sustain partnerships with government counterparts and national stakeholders to facilitate programme implementation and improve access to WASH services in institutions.
- Prepare advocacy materials to promote awareness, establish partnerships, and support fund-raising for WASH in Institutions and adolescent WASH programmes.
- Participate in inter-agency discussions to ensure UNICEF's priorities are integrated in UNDAF development planning and agenda setting.
- Mobilize partners to ensure systemic inclusion of feedback from youth, adolescents, and children.

## 8. Innovation, Knowledge Management, and Capacity Building:

Lead the development, implementation, monitoring, and documentation of WASH
action research and innovations (including human-centered innovations) focused on
climate change adaptability.

- Prepare knowledge products covering innovative approaches and good practices to support WASH sector development.
- Create and deliver learning opportunities for UNICEF WASH staff to maintain sector capacity up-to-date with latest developments around WASH in Institutions (WASH FIT, Ami de WASH, JMP) and adolescent WASH.
- Conduct capacity gap analyses and design initiatives to strengthen capacities systematically.
- Act as a resource person in capacity-building initiatives for clients and stakeholders.

## 9. Safeguarding and Participation:

 Ensure adherence to child/youth participation and safeguarding principles in all campaigns, communication products, and platforms.

## 10. Project and Budget Management:

- Coordinate day-to-day delivery of key projects and workstreams, ensuring progress and addressing obstacles.
- Ensure the effective and transparent use of budgets and resources.

## 11. Stakeholder Engagement:

- Identify, build, and maintain formal and informal partnerships and networks through proactive collaboration with internal and external partners.
- Conduct stakeholder mappings to identify relevant partners for potential collaboration with UNICEF.
- Prepare partnership materials and briefs, supporting partnership management and communication.

#### Others:

Undertake other key responsibilities as required.

## **CHILD SAFEGUARDING**

Child safeguarding involves proactive measures to limit direct and indirect collateral risks of harm to children, arising from UNICEF's work, UNICEF personnel or UNICEF associates. The risks may include those associated with: physical violence (including corporal punishment); sexual violence, exploitation or abuse; emotional and verbal abuse; economic exploitation; failure to provide for physical or psychological safety; neglect of physical, emotional or psychological needs; harmful cultural practices; and privacy violations.

By prioritizing adolescent perspectives and experiences, WASH interventions become more inclusive and responsive, ultimately leading to improved access to WASH services for vulnerable populations.
- **WASH in Institutions:** The support provided by the WASH specialist will enable the country office to achieve the WASH-related output results of the country program with a specific focus on improving access to WASH in schools and health centers in Madagascar through national monitoring and fundraising.
- Resilient Emergency Response: Through effective humanitarian WASH
  preparedness and response, the specialist ensures that adolescent needs are
  prioritized and integrated into emergency interventions. By considering the unique
  vulnerabilities and requirements of adolescents during crises, the specialist contributes
  to building more resilient communities and institutions, better equipped to withstand
  and recover from emergencies.
