Purpose of Activity/Assignment:

UNICEF is working with the Chinese Ministry of Education to support the integration of adolescent life skills (also known as transferable skills, 21st century skills) into its Technical and Vocational Education (TVET) in order to better prepare the students for school to work transition. This includes work to develop a China specific and age-appropriate life skills framework, assessment strategy and tools, and complementary learning resources to enable the integration of life skills into school and TVET curriculum.

UNICEF China Education team is now seeking to engage an international consultant to provide technical input, expert review, international perspective and quality assurance to support

- 1. Development of China specific adolescent life skills framework, including assessment strategy
- 2. Development of a learning strategy to integrate life skills into school and TVET curriculum, building on best international practice and evidence.

Scope of Work:

The scope of work will mainly cover two major assignments:

Assignment One mainly involves providing technical input and expert reviews of the draft life skills framework, advise on the design and process of framework development based on strong international evidence and best practice, and comparative analysis to align the framework against internationally studied/evaluated standards. The assignment will also involve providing technical inputs to formulate a strategy and roadmap to integrate life skills into assessment system and to expert review relevant assessment tools based on best international practice. The consultant will work closely with the Shanghai Normal University (SNU) expert team, UNICEF and MoE, actively engage in technical discussions and provide several rounds of expert reviews according to a mutually agreed schedule.

Assignment Two mainly involves providing technical input to development of learning strategy, including international mapping of good practice and evidence, advise on options of roadmaps to integrate life skills into school and TVET system, develop guidance on corresponding pedagogical approach and quality assurance mechanism. The consultant will work with UNICEF, MoE, the learning material development institutions and national curriculum experts, actively engage in technical discussions and provide several rounds of expert reviews and proposal according to a mutually agreed schedule.
