Project Overview:

Commercially produced complementary foods (CPCF) can contribute to improved nutritional intake for infants and young children (IYC) provided they are appropriately fortified and of optimal nutrient composition. Studies have shown that it is not always possible to meet the nutrient needs of IYC from local foods alone, particularly in resource poor settings. Hence, the production and consumption of affordable, nutritious CPCF can help close the nutritional gap and contribute to improved IYC growth. However, lack of national standards for CPCF may result in the formulation of products high in sugar and salt and low in important micronutrients such as iron, zinc, calcium, and vitamin D.

The Consortium for Improving Complementary Foods in Southeast Asia (COMMIT) was established to help ensure that the commercially produced complementary foods (CPCF) sold and consumed in the region contribute to healthy diets instead of unhealthy ones. To do this, COMMIT developed and implemented activities to help identify current consumer CPCF preferences, examine current CPCF nutrient composition and labelling requirements for products sold in Southeast Asia, and analyze the strength of existing national legislation regulating CPCF. The results from these activities were used to develop two tools: 1) a Model Mandatory CPCF Standard; and 2) a CPCF Framework for Action. These tools, and the evidence generated through the activities, are intended to equip Government decision-makers with the information they need to implement robust and enforceable regulations on CPCF nutrient composition and labelling practices.

UNICEF Cambodia is providing technical support to the Ministry of Commerce, Ministry of Health, Ministry of Industry, Science, Technology and Innovation, Ministry of Information, Ministry of Economy and Finance, and Ministry of Agriculture, Forestry and Fisheries to review and adapt the COMMIT Model Mandatory CPCF Standard for the Cambodian context and adopt this National Standard for CPCF. The National CPCF Standard will be based on the COMMIT Model CPCF Standard which amalgamates all global guidance on regulations for CPCF nutrient composition, labelling practices and production standards available from Codex Alimentarius (Codex), the World Health Organization (WHO) and the European Union's Commission Directive. Stakeholders will further review and adapt the COMMIT Framework for Action to modify and produce recommended supportive materials for the Cambodian CPCF Standard including the CPCF Manufacturer Guidance and the CPCF Regulatory Checklist.

Purpose of Activity/Assignment:

The consultant will provide technical support and backstopping to facilitate the national review, adaptation, and adoption of the COMMIT Initiative Model CPCF Standard into a National CPCF Standard in Cambodia to improve child diets to prevent wasting and other forms of malnutrition. The consultant will further support the review and adaptation of the recommended supportive materials in the Framework for Action to facilitate the implementation and enforcement of the CPCF standard within the country. Scope of Work:			
Lead the coordination of government agencies and development partners for the dissemination of COMMIT findings in Cambodia and review and adaptation of the COMMIT Model Mandatory CPCF Standard in Cambodia. Key responsibilities will include:			
 a. Facilitate the dissemination of the COMMIT Initiative findings in Cambodia and the development of a joint workplan for the development of a Mandatory CPCF Standard and supportive materials in Cambodia. i. Supportive materials include a Manufacturer guidance for CPCF, CPCF Regulatory Checklist and CPCF calculator for Cambodia based on the Cambodian CPCF Standard. b. Lead the drafting of the national standard for CPCF in Cambodia i. Coordinate and liaise with government agencies and develop partners to ensure that all partners stay actively engaged and meet expected timelines within the joint workplan to draft the national standard. ii. Lead coordination with international experts supporting technical backstopping for the COMMIT Initiative in Cambodia iii. Coordinate the development of supportive materials in the COMMIT Framework for Action including the Manufacturer guidance for CPCF, CPCF Regulatory Checklist and CPCF calculator. c. Prepare a final report about the drafting process inclusive of key enabling factors and limiting factors
