### **Background**

There are sixteen district vaccine stores in all the sixteen districts in the country for storage of both routine and mass vaccination campaigns. Findings from recent cold chain assessment revealed that some of these stores are in a poor state of repairs and needs renovation and in some cases expansion for adequate storage of immunization supplies. To address this, the country developed and submitted a proposal to GAVI, and the proposal was approved with funding provided to construct three district vaccine stores (Kambia, Bonthe and Kenema), solarize two district vaccine stores (Bonthe and Kambia) and central EPI vaccine store in Freetown. In addition, the Health and Nutrition section with funding from the Global Fund and UNICEF ACT-O-SFF is in the process of constructing 7 plant houses for installation of PSA Oxygen plants in selected facilities across the country and several other projects to install solar power systems in Special Care Baby Units (SCBUs) in various hospitals

The UNICEF Health & Nutrition Section is recruiting a Construction Engineer, who will be responsible for managing these projects and provide general oversight and management for all the phases of these construction and solarization works in the districts and central EPI vaccine stores.

### **Purpose and objectives**

Under the guidance of the Immunization Specialist and Chief of Health & Nutrition Section, the Construction Engineer will monitor progress and quality of the construction and solarization of three district vaccine stores (Kambia, Bonthe and Kenema) and the construction of oxygen plant houses. The consultant will engage with the third part construction supervision firm and contractors on a regular basis and provide on-site support to them as they complete their activities, while simultaneously liaising with the UNICEF Immunization Specialist, Chief of Health & Nutrition Section, EPI manager, MoHS engineers and supply sections in UNICEF Sierra Leone and headquarters to provide updates and troubleshoot as necessary.

Specific objectives include:

- Provision of technical oversight to UNICEF-supported construction works
- Enforcement of nationally recognized construction standards
- Quality assurance and compliance monitoring to ensure timely and quality completion of UNICEFsupported construction works

### Methodology and Technical Approach

The Construction Engineer will be full-time and based in UNICEF Freetown with frequent travels to the field in line with work plans and deliverables. The incumbent will work under the supervision of the Immunization Specialist, with support from the Chief of Health & Nutrition Section and Supply colleagues at Country offices and Supply Division. ### **Activities, Tasks, Outputs and Deliverables**



### Deliverable 1: Report on proposed building plans selection process and Government approval for each site

Key activities related to Deliverable 1:

- Responsible for the overall supervision/coordination of all construction activities with special focus on project and contract management.
- Act as advisor to the UNICEF Procurement Unit and Contracts Review Committee (CRC) in the selection of local technical partners and contractors.
- Review and verify proposed building plans for technical soundness, environmental and sustainability considerations; ensure final drawings and BOQs are approved by UNICEF and MoHS; and final sites are formally handed over by MoHS to the contractor with proper documentation before works begin.
- Ensure proposed works are approved by relevant government authorities prior to commencement
  of works and compliance with the Sierra Leone national construction codes and MoHS minimum
  standards for establishing district vaccine stores.
- As needed ensure the contractor understands the contents and intents of the Construction Contract Documents, such as the working drawings, specifications and general conditions.

# Deliverable 2: Availability of filing system for all site memos and instructions, measured quantities of work, and material on site, reports, and other documents and correspondence pertaining to the construction activities (updated monthly)

Key activities related to Deliverable 2:

- Ensure detailed records are kept of all construction activities, enabling real-time tracking of construction progress.
- Check and approve material and equipment incorporated in the works, ensuring compliance with designs, specification, and safety regulations. Manage allocated resources at all levels during the construction period and supervise responsible partner in charge of quality assurance
- Check and approve material and equipment incorporated in the works, ensuring compliance with designs, specification, and safety regulations. Manage allocated resources at all levels during the construction period and supervise responsible partner in charge of quality assurance.
- Maintain a filing system for all site memos and instructions, measured quantities of work and material on site, reports, and other documents and correspondence pertaining to the construction activities

#### Deliverable 3: Quality assurance and compliance monitoring work plan

Key activities related to Deliverable 3:

• Develop work plan for the implementation of quality assurance strategy and monitor compliance to ensure objectives and targets are met and achieved.

### Deliverable 4: 12 monthly quality assurance and compliance monitoring reports

Key activities related to Deliverable 4:

- Visit each active construction site at least once every month); site visits should be timed to
  coincide with significant construction activities, foundation excavation completion, steel fixing
  and formwork inspection, concrete pouring, roof structure inspection and formwork striking.
- Monitoring, verification, and certification of construction works, working closely with the construction monitoring team comprising UNICEF and MoHS engineers and other district level

partners by deploying the latest construction management principles and make recommendation to UNICEF on all claims of the Contractor(s) relating to the execution and progress of the work, such as progress payments, variation orders, contract time extensions and suspensions

- The Construction Engineer shall keep UNICEF informed of defects and deficiencies in the work of contractors and shall condemn work found failing to conform with the Contract Documents, Annexes or Special Provisions of the Construction Contract, if any, and decisions of UNICEF as conveyed
- Identify any delays or cost overruns and ensure timely reporting to UNICEF supervisor with suggestions of acceptable mitigating measures.
- Assist in the review and evaluation of the technical, institutional and financial feasibility and constraints of the project in coordination and collaboration with government and other partners.
- Arrange and conduct of regular site meeting with the contractor/s and submit site meeting reports
  to Immunization Specialist within 5 working days of the meeting, this includes ensuring weekly
  and monthly progress reports are prepared and submitted to detailing the following:
  - Site construction progress (percentage completed) and compared to the baseline (original) program.
  - Current payment certification status.
  - Current forecast completion date.
  - Resources being provided by contractors.
  - Current or anticipated problems and proposed solutions including likely deviations from timing and costing plans
  - Quality and efficiency of supervision set up.
  - Variation orders issued (from the original scope of works) with cost, time and quality reporting elements.
  - Other tasks as requested.

## Deliverable 5: Report on implementation progress and lesson learned for construction workers for each donor report

Key activities related to Deliverable 5:

- Ensure lessons learnt are incorporated into design and construction process before initiating the next phase of the construction.
- Produce narrative reports on implementation progress and lessons learnt for use as inputs into
  donor reports and disseminated to MoHS and DHMTs, this includes documenting of lessons
  learned in the construction works for sharing with the UNICEF global Construction Unit, Supply
  Division, and wider dissemination.
