1. BACKGROUND AND PURPOSE

India is committed to achieving the maternal and newborn health targets of the Sustainable Development Goals (SDGs), the Global Strategy for Maternal, Child and Adolescent Health and Every Newborn Action Plan and the Government of India National Health Policy, 2017 targets to end preventable maternal and newborn mortality and stillbirths. The SDG 2030 goals entail a reduction of maternal mortality to below 70 per 100,000 live births from the current level of 97 per 100,000 live births and reducing new-born mortality from current levels of 20 per every 1,000 live births to less than 12 per 1,000 live births

In recent years, quality of care (QoC) and Respectful Maternity Care (RMC) has gained renewed focus and prioritization even at the highest political level in the country. LaQshya initiative is a flagship program of the Government of India to 'fast track' attainment of quality-of-care standards for maternal and newborn care services across government health facilities in the country with focus on aspirational districts. As per NFHS-5, there is a substantial increase in Caesarean Section deliveries, particularly so in the States of Andhra Pradesh and Telangana which is a matter of concern. Also, there is urgent need to revise the current SBA guidelines which was developed in 2009. The purpose of the assignment is to fast track the quality of maternal health services initiatives particularly focusing on the day of birth for reducing maternal mortality. The consultant will be supporting Ministry of Health and SDG priority initiatives like revision of SBA guidelines under guidance of MoHFW; dissemination of caesarean section guidelines; supporting states for achieving the LaQshya certification; strengthening PMSMA; Midwifery Initiative, roll out of Obstetrics HDU and ICU and the recently launched initiative for zero preventable maternal and newborn deaths (SUMAN).

To provide technical assistance to the implementation of the national and state initiatives to scale-up and strengthen the quality of maternal health programs, by providing technical assistance to MoHFW and supporting the UNICEF programming states on quality of care (QoC) initiatives for maternal health services thereby contributing to the reduction of stillbirths and newborn & maternal mortality.

The purpose of the assignment is to provide technical assistance and consultancy support for maternal health for improving the quality of care at birth to reduce the morbidity and mortality for mother baby dyad. The consultant will provide technical support, coordinate with, and monitor service providers, liaison with state governments and develop implementation frameworks for phase wise implementation for strategies to reduce annual rate of reduction for maternal mortality in order to achieve the Sustainable Development Goal targets for maternal health.

3. Roll out of Midwifery Initiative in UNICEF programming states
4. Detailed report on the Obstetric HDU-ICU roll out in UNICEF programming states based on assessment of selected Hospitals in UNICEF programming states

5. Development and submission of reports on maternal and neonatal health based on detailed data analysis using open-source data available for UNICEF programming states, national and global reports
