1. BACKGROUND / RATIONALE

The Integrated Scheme on School Education (Samagra Shiksha) of Government of India, envisages education as continuum and has developed an overarching programme for the school education sector from pre-school to senior secondary to improve quality of education for all children in the country. The vision of the scheme is to ensure inclusive and equitable quality education from pre-school to senior secondary level and in alignment with the Sustainable Development Goal (SDG) of Education. Education Management Information System (EMIS) plays an important role in in the effective planning and monitoring of the Samagra Shiksha and Unified System for School Education Plus (UDISE+) is the management information system of school education covering more than 1.5 million schools, 9.4 million teachers and 248 million children for effective policy and planning in the country.

UNICEF continues to provide technical assistance to Government of India and State governments in strengthening data management systems, building capacity of education functionaries to support planning, implementation, and monitoring of the education programme. Therefore, this consultancy support is required to help strengthening systemic capacity in the use of data and evidence to support planning and implementation of the education programme.

2. PURPOSE OF ASSIGNMENT

The purpose of consultancy is to:

- i. To improve use of data and evidence in education sector planning and monitoring
- ii. To develop policy briefs on key thematic areas related to access, learning and budgets to inform education sector policy and planning

The support encompasses both direct programmes work with government functionaries as well support UNICEF teams working in 17 states to support policy planning and monitoring of education programme.
